SIR,

I, Savita Bhowmick, alias Savita Shil, Daughter of Dulal Shil, wife of Biswajit Natto, matrimonial home in Telipara, Post office Ghogomali, P.S Bhaktinagar, Distict- Jalapiguri and parental home in Near Botol Company, Baikantha Pally got married for the second time to Biswajit Natto 1.5 years back .My first husband passed away seven years back and out of the wedlock from my first marriage, I have a 12 year old daughter Piyali Bhowmick. The marriage with my second husband was first proposed by my husband Biswajit Natto to my parents and with the consent and approval of both the family members, my marriage had taken place. At the time of my marriage, he (Biswajit Natto) assured and promised me that he will take my and my daughter's full responsibility. Before my marriage with my second husband, I use to work but soon after the marriage, he did not let me to work nor provided me with any financial assistance for me and my daughter. This resulted into due of school fees of my daughter and on asking him to provide money for my daughter's school fees, he use to shout and yell, used filty language to me and at times also he hit me several times. My husband even use to drink and use to throw me out of his room and then again use to drag me to his room at night. He threatened me at road that he will throw acid on me someday and will then do murder and run away to Nepal. Such kind of painful and harassing threats was

given to me and gives to me whenever he gets an opportunity to do so. Got worried and tensed by the situation, I use to take financial help from my parents sometimes and other times I use to manage to provide salon home services somehow. Aggreived by such humiliating torture and harassment, I somehow managed to come back to my parental home to secure my and my daughter's safety. But there also he came and used filty language and threatened my family members that he will commit murder to them .Now, whenever I travel or go anywhere or in my workplace, he follows me, uses filty and slang language in the road and picks up stones to throw on me and lastly threatens me that he will commit suicide and put the entire blame on me and my family members for harassing me and not letting me live a peaceful life. He also threatened me that he will not let my daughter to study in school and hamper her life mentally and in academics for which he also took the possession of my daughter's school books. I informed the school authority about it and thereafter the school head called my husband and told him that not to bring personal problems in between my daughter's studies. Thereafter, he came to the school and released my daughter's books.

He even threatened me that he will not let me work at my current workplace and will somehow create a mess in my workplace that the owner would throw me out. Such kind of threat is troubling me and I am in tension that how will I feed myself and my daughter.

He also asked me financial assistance of Rs. 1 lac soon after my marriage which I kept it as a safety and security and promised me to return back soon. But since a year passed away, he neither returned the money and on asking the same, he said that he won't return the money I if I don't stay with him.

It's been around one and half months, I am in my parental home and then on around 23rd or 24th of July, I took a rented house next to my parental house where also he came and created a scene and mess. On 30th July around 9.30 pm when I came back from my work, he took

away my phone and did not return me back, he had hit me and used dirty and filthy language and had beaten me so hard the whole night that I had to run to Siliguri Hospital the next morning i.e on 31st of July, around 6.30 -7 am. Before I could reach the hospital, he himself went to the hospital on his bike and hit himself on his body and showed doctor those false injuries which he himself created by himself and somehow managed to get a doctor certificate for himself just to harass me and put me into more trouble.

On such circumstances, I want to lodge an F.I.R against my husband Biswajit Natto for such mental harassment and torture. I would be highly obliged if you register my F.I.R and take the necessary steps as soon as possible.
