In producing herewith one accused person namely Surajit Sarkar @ Pintu-31yrs s/o Sunil Sarkar of Janatanagar, PO Sevoke road, Ward No- 42, P.S- Bhaktinagar, Dist-Jalpaiguri in custody and the following property under seizure along with seizure list:-

i. 20 (Twenty) Bottles of ALTOREX-CD Cough Syrup each bottle containing 100 ML having Composition Codeine phosphate IP 10 mg, Chlorpheniramine Maleate IP 04mg, (Total weight 20 pcs X100 ML=2000ML = 02 Liter) and Marked as exhibit-"A"

ii. One Two wheeler Scooty"HONDA GRAZIA" bearing Registration No-

WB74BG/1193

iii. One i-phone-13 (Apple) mobile phone, blue colour having IMEI No-353504867373643 & 353504867873147.

I, SI Mrinal Basunia s/o Sri Manmatha Basunia of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 02.08.2023 at 21.35 hrs received a secret source information that one person having possession of huge quantity of Narcotics Substances in his possession without valid documents and selling to the addicted young boys and school /college going students at P.C Mittal bus stand under PS- Bhaktinagar. Accordingly the information was diarized vide BKN PS/SPC GDE No. 107 Dtd. 02.08.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, SI Rantu Halder, ASI Dipak Karmakar, C/1431 Dilip Barman, Const/374 Debraj Biswas, all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-1273/23 Dt. 02.08.2023 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 108 Dated. 02.08.2023 At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 21.55 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Ranjit Roy s/o Kartik Roy of Bholanathpara, Ektiasal, PO Ghugumali, P.S- Bhaktinagar, Dist- Jalpaiguri, and (ii) Biswajit Roy s/o Lt Dinesh Roy c/o Nitesh Sharma of Nimbu busty, Below Maszid, ward No-42 PS Bhaktinagar Dist Jalpaiguri P.S- Bhaktinagar, Dist- Jalpaiguri also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 22.00 hrs as shown and identified by the source, we found one person was standing at P.C Mittal bus stand near Tower under PS- Bhaktinagar with his scooty and we detained the above noted person along with Scooty. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he is carrying and possessing "Narcotics Substances" with him. Then I asked him whether he wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But they refused to search by the police party. Then I informed the matter to special Executive Magistrate and requested him to come at P.C Mittal bus stand under PS-Bhaktinagar to remain present and supervise the search and seizure as he being a special Executive Magistrate. After some time Special executive magistrate Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC arrived at the spot. I disclosed the identity of Shree Maksadur

SI Morinal Basunia.

Rahaman ACP/SPC & ICP Fulbari/SPC to the apprehended person and witnesses as a Special executive magistrate. Thereafter under the supervision Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC and in presence of him and independent witnesses I conducted search of the above apprehended person keeping strict regard and found the articles as per seizure list which was possessing/carrying by the apprehend person and which was kept in his dickey of his scooty. On being asked he further confessed in presence of Special executive magistrate and other witnesses that he procured the Narcotics Substance clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for his wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Bhaktinagar PS. On examination of the alleged apprehended person noted above regarding any documents for carrying/possessing of said Narcotics Substance he failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC) I seized the articles under proper seizure list and Label under the supervision of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC in presence of witnesses duly signed by them as well as the accused person and marked the seized exhibits as noted above. As per request Whole process has been photographed by photographer Sushil Chatterjee of Arabindapally, Near Rathkhola PS Siliguri Dist Darjeeling.

The seizure and label was made between 22.50 hrs to 23.25 hrs. The whole process of search and seizure was video graphed. Then I arrested the above noted accused person u/s-41 Cr.P.C after observing all formalities of arrest and disclosed them cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing cough syrup without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Surajit Sarkar @ Pintu-31yrs s/o Sunil Sarkar of Janatanagar, PO Sevoke road, Ward No- 42, P.S- Bhaktinagar, Dist- Jalpaiguri and Others and arrange for its investigation.
