In producing herewith the following 04 (four) persons arrested namely 1. Gobinda Roy (48yrs) S/O- Lt Nanda Roy of Shanti Colony, Ektiashal, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Bishnu Roy (32yrs) S/O- Phulendra Nath Roy of Gouranga pally, Sarat Chandra Pally, Haidarpara, PS-Bhaktinagar, Dist-Jalpaiguri 3. Gopen Biswas (52yrs) S/O- Jaydeb Biswas of boro Fapri, Near Loknath Mandir, P.S. Bhaktinagar, Dist- Jalpaiguri 4. Kalia Banik (20yrs) S/O- Lt Situ Banik of Anadamaye Kalibari road, Haidarpara, P.S- Bhaktinagar, Dist-Jalpaiguri under arrest along with the following seized articles:-

1. One iron made 'Hasua' attached with wooden handle measuring about 16 inch" with handle recovered from the possession of Gobinda Roy (48yrs)

2. One iron rod measuring about 26" inch recovered from the possession of Bishnu Roy (32yrs)

3. One iron rod measuring about 29" inch recovered from the possession of Gopen Biswas

4. One iron rod measuring about 22" inch recovered from the possession of Kalia Banik (20yrs)

I, SI Rantu Haldar of Bhaktinagar PS/SPC would like to lodge this written complaint against the above noted persons and 5/6 others persons to the effect that today i.e on 03.08.2023 at about 12.30 hours when myself along with, C/374 Debraj Biswas, C/1431 Dilip Barman CV/014 Labanyamay Barman CV/614 Sumit Kr Roy was performing night mobile duty at that time received a secret source information that a group of 08/09 persons had assembled at Near Dada Vai Colony under Bhaktinagar P.S with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to I/C Bhaktinagar PS over telephone and as per telephonic instruction we rushed to the spot to verify the veracity of the information and to work upon it.. We reached near the spot as directed by the source at about 01.15 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement at about 01.25 hrs and found a group of 08/09 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04(four) above referred accused persons. On interrogation the 04(four) persons disclosed their identity as noted above and confessed 5/6 other persons with them. They had assembled there with a view to commit dacoity after making full preparation in the house of Near Dada Vai Colony adjacent areas. Thereafter all the apprehended persons were searched in presence of the witnesses and the above noted articles was recovered.

All the articles were seized between 01.40 hrs to 02.05 hrs issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested between 02.05 hrs to 02.15 hrs as they had assembled for committing heinous crime.

SI Rantu Haldar:

Under the above circumstances, I pray before you that a specific case U/S 399/402 I.P.C may kindly be started against the 04 (four) persons arrested namely 1. Gobinda Roy (48yrs) S/O- Lt Nanda Roy of Shanti Colony, Ektiashal, P.S- Bhaktinagar, Dist-Jalpaiguri, 2. Bishnu Roy (32yrs) S/O- Phulendra Nath Roy of Gouranga pally, Sarat Chandra Pally, Haidarpara, PS-Bhaktinagar, Dist-Jalpaiguri 3. Gopen Biswas (52yrs) S/O- Jaydeb Biswas of boro Fapri, Near Loknath Mandir, P.S- Bhaktinagar, Dist- Jalpaiguri 4. Kalia Banik (20yrs) S/O- Lt Situ Banik of Anadamaye Kalibari road, Haidarpara, P.S- Bhaktinagar, Dist- Jalpaiguri and 5/6 other persons for assembling with deadly weapons with a view to committing dacoity.
