- 1. Kindly refer your Memo No 36/DIG.DR.DIG/MISC dated 08 Feb 2023.
- 2. It is submitted that GS-176733F Store Supervisor Sanjay Kumar Prasad of this Task Force under Project Brahmank was proceeded for 89 Days leave wef 28 Dec 2021 to 27 Mar 2022. On expiry of said leave individual did not report on duty on 28 Mar 2022 so far. As per information received from NOK of the individual, Smt Sheela Verma, he boarded Train No 15657 (Brahmaputra Express) from Buxar to Rangiya on 24 Mar 2022 for onward journey to Murkongslek and the individual had reached at Rangiya on 25 Mar 2022 and contacted with his wife in mobile. But till date neither the individual had rejoined his duties at HQ 761 Border Road Task Force nor contacted his wife Smt Sheela Verma. In the course of action, FIR has been lodged by NOK, Smt Sheela Verma with Police Station Sikanderpur, Ballia, and hometown of the individual. In their investigation report, it has been clearly stated that the mobile tower of the individual has been traced at Siliguri location according to the CDR location.

In view of above, may I request your good self to instruct concerned police station at Siliguri to lodge FIR as per Police Investigation Report of SHO Sikandarpur, Balia (UP) (copy enclosed for ready reference) and further investigation report be issued from PS Siliguri to process the legitimate claims to NOK of the individual, as it is a mandatory document to process his case to Ministry of Defence.
