I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Navin Bansal (Present user), (Ph No-9635723283), M/S Bimal Furnishing, Himachal Sarani By Lane, Haiderpara, Siliguri, Dist- Jalpaiguri for having committed offence as stated here under.

On 03.08.2023 at about 01.50 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the commercial building of Navin Bansal and inspected service installation, metering installation of Consumer ID 401365651 in the name of Bimal Kr. Kedia. During inspection it was found that electricity was being used unauthorisedly & illegally by Navin Bansal by reconnecting the disconnected service line of the metering installation that was disconnected previously on 18.07.2023 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Landies & Gyer Ltd, serial no:- L4243875 installed against Con Id. 401365651 seized by preparing a formal seizure list duly signed by Navin Bansal and witnesses. The copy of the seizure list handed over to Navin Bansal and his signature obtained as token of receipt.

As Navin Bansal have committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
