Respected Sir,

I, **RAMPRAKASH CHOWDHURY**, S/O Late Supan Chowdhury, resident of Kolie Para, Rajendra Nagar, Kolie Patti, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, I do here by want to inform you as follows :-

1. That I am the law abiding citizen of India, and a permanent resident of aforesaid address.
2. That I reside along with my family members namely Shivnanadan Chowdhury, Ravi Chowdhury, Kanaiya Chowdhury, all are my sons, Kanika Devi Chowdhury, my wife and Rita Kamti, and Anushka Chowdhury, my daughters at the aforesaid address.
3. That 03.08.2023 due to heavy rainfall there was a water logging in front of the main gate of my house, my daughter namely Rita Kamti went to wipe out the logged water through wiper and at that time one of my relative namely Debanti Devi, W/O Hareram Chowdhury while passing from that passage, Rita Kamti's body slightly touched with the body of Debanti Devi, W/O Hareram Chowdhury.
4. That thereafter suddenly the other relatives of **DEBANTI DEVI**, W/O Hareram Chowdhury namely **SARITA DEBI**, **SANGITA CHUDHURY**, **SANJANA CHOUDHURY**, Daughters of Hareram Chowdhury, came in a aggressive manner and started to abuse my daughters and other relatives in filthy languages upon my daughters and other relatives and when my son after hearing the noise came to protest then the other relatives of **DEBANTI DEVI**, W/O Hareram Chowdhury namely **HARERAM CHOUDHURY**, S/O Late Supan Choudhury, **DIPAK CHOUDHURY**, S/O Hareram Choudhury, and **KRISHNA SAHANI**, S/O Bhuttu Sahani, resident of Sahani Patti, Samshan Ghat P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, suddenly came with the weapons namely iron puncher and iron rods and started to beat me and my other relatives mercilessly and attacked me and my family members mercilessly and strangulated my family members with an intention to kill us.

5. That subsequently me and my family members sustained severe injuries on head, forehead, ear, eyes etc., and moreover my son namely Kaniya Choudhury is in a serious condition due to the severe head injuries.
6. That the above named person also tried to ransacked my house and when we started to scream the other neighbours and relatives rushed to the spot and those culprits also fled away.
7. That subsequently me and my family members were taken to Siliguri District Hospital for our severe injuries.
8. That the above named accused persons always used to throw filthy and slang words upon us and whenever we tried to protest the same they used to threat us that they can do anything with us and if we dare to take any legal action against them they will kill us.
9. That thereafter the above named persons are very much desperate and started to threatened us that they will take revenge from us by killing all my family members.
10. That still that accused person as they are too much desperate in nature did not allow us to stay in my house peacefully and as a result we has to spent our days as bewildered condition and the life and dignity and honour of us are in danger and we are passing our days with great fear/tension/anxiety for the continuous threat given by above named accused persons.
11. That I am a helpless person and seeking justice from you by taking necessary legal action against the accused culprits, namely **DEBANTI DEVI**, W/O Hareram Chowdhury, **SARITA DEBI**, **SANGITA CHUDHURY**, **SANJANA CHOUDHURY**, Daughters of Hareram Chowdhury, **HARERAM CHOUDHURY**, S/O Late Supan Choudhury, **DIPAK CHOUDHURY**, S/O Hareram Choudhury, and **KRISHNA SAHANI**, S/O Bhuttu Sahani, resident of Sahani Patty, Samshan Ghat P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, and take the necessary legal steps as our life are in very much danger and the above named accused persons can any time attack us.
