Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Flyover Approach, Venus More without any valid documents causing obstruction to public way.

Sir,

I SI Samad Ali Mandal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 04.07.23 around 12.40 hrs, while on duty at Venus More found one (1) TOTO with any registration number stationed at Flyover approach, Venus More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Giku Ghosh (23 Yrs), Mobile No-9339505326, S/O- Anil Ghosh of Panchkelguri NJP Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above named person (TOTO Driver) under proper section of law from your end.
