Dear Sir,

With due respect and humble submission, I, SMT. ASHA PERIWAL, w/o. Shree Sushil Kumar Periwal, aged about 66 years, Senior Citizen, resident of 453, Bidhan Road, Siliguri, Pin - 734001, do hereby states that yesterday on 03/08/2023 at about 4.10 / 4.15 p.m. while I was walking towards "UNIQUE SWEETS " (Mangaldeep Building) from other side of the divider, Hill Cart Road, Siliguri and after crossing the divider while I was on the road one motorbike negligently and reclessly came out from the lane, by the side of said Mangaldeep Building, and Hit me and ran away. By this severe hit I fell down on the road and became unconscious, so I could not able to see the number of the said motorbike. Some nearby people rushed towards me and helped me in standing and gave me water and moral First Aid. I felt I have some injuries on my head , hands, elbows, legs and hips. With the help of those people I have any how managed to reach my home. After taking a rest I felt I became unable to move my body and organs. Because of severe pain I could not even get down from the bed. Today also the situation is same so I have requested my Ld. Advocate Mr. Ashoke Kumar Prasad to lodge this F.I.R. on my behalf. He has agreed to do so.

Under the above facts and circumstances I humbly request you to look into matter and get the culprit and take the strong steps against this inhuman, careless and recless driver.
