That from 01-04-2023 to 07-05-2023 the complainant did his business turnover of Rs. 12,06,998/- (Rupees Twelve Lakh Six Thousand Nine Hundred Ninety Eight) only and all the denominations of currency or the above mentioned amount were made up by Rs.500/- X 2400 = Rs.12,00,000/-(Rs Twelve lakh) only; Rs. 200/- X 30 = Rs. 6,000/- (Rupees Six Thousand) only ; Rs.100/- X 9 = Rs. 900/- (Rupees Nine Hundred) only; Rs.50/- X 1 = Rs. 50/- (Rupees Fifty) only; Rs.20/- X 2 = Rs. 40/- (Rupees Forty) only; Rs.5/- X 1 = Rs. 5/- (Rupees Five) only (in Coin); Rs.2/- X 1 = Rs. 2/- (Rupees Two) only; Rs.1/- X 1 = Rs. 1/- (Rupees One) only; (in coin); **IN TOTAL Rs. 12,06,998/- (Rupees Twelve Lakh Six Thousand Nine Hundred Ninety Eight) only.**
6. That on very next day i.e., 08-05-2023 at about 10:00 to 10:30 hrs, when your Complainant open his shop it was came to the knowledge of your complainant that the locker was broken and all the cash was stolen from such locker.
7. That after that your complainant search everywhere and he found that the ceiling of the shop was broken.

That after some enquiry it came to my knowledge of your complainant that one **SUNIL ROY, Son of Bimal Roy, resident of Salugara, Vivekananda Nagar, Beside road of Sona Patrol Pump, Behind Army Ground, Police Station - Bhaktinagar, Dist - Jalpaiguri** who also a worker of my shop stole the above mentioned money

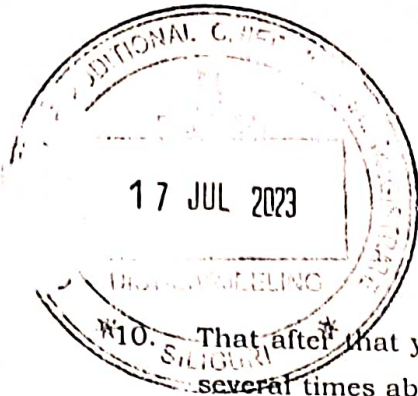
