In producing herewith arrested accused namely (i) Tamal Sutradhar (34 yrs/M) S/o- Dulal Sutradhar of Das Colony, South Bharat Nagar , W/no- 24, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- i) Ten (10) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit each containing 600 ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs. 120/-*10=Rs 1200/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.


I, ASI Debasish Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the accused person namely Tamal Sutradhar (34 yrs/M) S/o- Dulal Sutradhar of Das Colony, South Bharat Nagar , W/no- 24, PS- Siliguri, Dist- Darjeeling to the effect that on 04.08.23 at 21:55 hrs received secret source information that the above noted accused person busy to sale ld Liquor illegally at his shop situated at South Bharat Nagar near Jora Pani Bridge under Siliguri PS area. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with , ASI Subir Sen, CV/622 Ramanath Barman, CV/283 Prasenjit Dey and others left for South Bharat Nagar under Siliguri PS vide Siliguri PS GDE no- 221 dated 04/08/23. On reaching at 22:20 hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted accused person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit at his shop without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search Ten (10) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit in which one sealed bottle has taken as sample as per seizure list. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by the witnesses. The seizure and label was made in between 23:05 hrs to 23:30 hrs. As such I arrested him U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused namely Tamal Sutradhar (34 yrs/M) S/o- Dulal Sutradhar of Das Colony, South Bharat Nagar , W/no- 24, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigation.
