Sir,

In producing herewith the 01 (One) arrested accused persons namely Md. Mukit Alam (22) yrs s/o Md. Khalil of Bahirgachhi, PO- Chatt Hat, PS-Phansidewa, Dist.- Darjeeling (Not verified) along with the following seized articles under proper seizure list :-

Total 01 number of Transparent Packet containing Total 622 Grams [Six Hundred Twenty Two Grams] Approx of suspect to be Brown Sugar Marked as follows :-

- (i) One transparent Packet containing 622 grams of Suspect to be Brown Sugar kept inside the dark green color hand bag marked as Exhibit-"A".
- (ii) Total 5,00,000/- (Five Lakh Rupees) cash all are in Rs-500/- (Five Hundred) rupees denomination kept inside the dark green color hand bag.
- (iii) One Dark green Color hand Bag.
- (iv) One silver Color Maruti Ritz bearing No.- WB/74U/6440.

I, SI Pradeep Dyalal of New Jalpaiguri Police station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted 01 (One) arrested accused person to the effect that today 01.08.2023 at about 1215 hrs I received a specific source input that one vehicle bearing registration No.- WB/74U/6440 would be coming from Phansidewa side and proceeded towards Siliguri side with huge quantity of Brown Sugar for delivering the same to his designed customers. The matter was diarized vide New Jalpaiguri PS PS GDE No.-28 Dt. 01.08.2023 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Khagen Barman, ASI Dhruba Mishra, C/453 Uttam Dey VP/13-Jamirul Islam and other officers and forces of Siliguri Police Commissionerate being headed by me left for Kawakhali, by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 29 dated 01.08.2023 and M.C.C. No. 1099/23 dated 01.08.2023. In the mean time. I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Kawakhali to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 1305 hrs we arrived at Kawakhali, near Biswa Bangla Shilpi Hat and on the way to the spot, I called two independent witnesses namely (i) Amit Paul (30) s/o Anil Paul (ii) Sukanta Barman (33) s/o Manik Barman both are of Porajhar, PS-New Jalpaiguri, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that one vehicle bearing registration No.- WB/74U/6440 is parked in front of Biswa Bangla Shilpi Hat, Kawakhali with 01 (One) person seated in driver seat inside the vehicle. which was matched with our information. Accordingly, as per indication of source we intercepted the vehicle bearing registration No.- WB/74U/6440 and apprehended the person who seated inside the vehicle and on being asked he disclosed his identity as noted above.

After disclosing our identity, we detained the above noted person with a strong reason to believe that he illegally possessing brown Sugar in his possession which he carrying in the vehicle for selling the same to his designed customers for his wrongful gain. On being asked he confessed that he possessed brown Sugar in his possession. I then gave him option in writing whether he wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. Then he agreed to be searched by any one of them. Further, I served him Notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended person to search our Police Party as per provision of law but they denied to search police party. Accordingly, I informed the matter to the Officer-In-Charge, NJP PS and as per his kind order I informed the fact to Shri Pasang Tobgey Bhutia, Assistant Commissioner of Police, Traffic East, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding the interception of the one vehicle bearing registration No.- WB/74U/6440 and apprehended one person with suspected to be possessed of Brown Sugar in the vehicle and requested him to come to the spot and to supervise the search and seizure if any being a gazette officer. Accordingly at 1405 hrs Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC arrived at the spot and accordingly, I disclosed his identity to the detained person as Special Executive Magistrate of Siliguri Police Commissionerate. Then in presence of Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC [Special Executive Magistrate] and two independent public witnesses searched the body of detained person following all formalities but could not recovered anything from his wearing apparel and in presence of Special Executive Magistrate and two independent witnesses search the vehicle

bearing registration No.- WB/74U/6440 and recovered One transparent Packet containing 622 grams of Suspect to be Brown Sugar kept inside the dark green color hand bag marked as Exhibit-"A" (ii) Total 5,00,000/- (Five Lakh Rupees) cash all are in Rs-500/- (Five Hundred) rupees denomination kept inside the dark green color hand bag. On demand in presence of the Special executive Magistrate he failed to produce any valid document in support of possessing of the brown sugar which he was carrying as well as without valid documents.

Thereafter, I weighted 01 (One) transparent packet containing 622 grams of said to be Brown Sugar in presence of Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC [Special Executive Magistrate] and the independent witnesses with the weighting instrument. Further, on demand in presence of Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC [Special Executive Magistrate] as well as independent witnesses the above noted detained person failed to produce any valid documents in support of possessing of Brown Sugar as well as huge amount of cash and also failed to produce any documents of the vehicle bearing registration No.- WB/74U/6440. Thus when his involvement in carrying and possessing brown sugar was established, then I seized the above noted articles from the exclusive possession of the above noted accused person at the spot at Kawakhali, in front of Biswa Bangla Shilpi Hat, under PS NJP, Dist.- Jalpaiguri under proper seizure list in presence of Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC [Special Executive Magistrate] as well as independent witnesses as noted above and acknowledged by the accused person in the seizure list and marked the seized articles as Exhibit-"A". Subsequently, I labeled the seized articles in presence of Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC [Special Executive Magistrate] and independent witnesses and accused persons as noted above. The whole process of seizure was made in between 1415 hrs to 1505 hrs on 01.08.2023 under the process of videography done by Tapan Mandal s/o Testa Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri. On further asked he confessed in presence of Shri Pasang Tobgey Bhutia, ACP Traffic East, SPC [Special Executive Magistrate] and other witnesses that he procured the brown sugar clandestinely from Phansidewa area for the purpose of supply the same to his designed customers at Siliguri area as per their requirement for his personal gain by illegal means. On Interrogation he also disclosed that he have been dealing in such business of selling the brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Md. Mukit Alam (22) yrs s/o Md. Khalil of Bahirgachhi, PO- Chatt Hat, PS-Phansidewa, Dist.- Darjeeling (Not verified) is involved in procuring and selling of Brown Sugar illegally and contravening the norms of NDPS Act was established, Then, I arrested the above noted accused person after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of Search, seizure labelled and arrest was made in-between 1415 hrs to 1525 hrs on 01.08.2023.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the above noted arrested accused person namely Md. Mukit Alam (22) yrs s/o Md. Khalil of Bahirgachhi, PO- Chatt Hat, PS- Phansidewa, Dist.- Darjeeling and others and arrange for its investigation.
