I, PARBA DEVI SAHANI, w/o. Lt. Suresh Sahani, s/o. V. U. Kaknyote  
beside Government Water Tank, P.O. Subhrutanagar, P.S. Maligara,  
Dist. Darjeeling, would like to inform you that as follows

1) That GETTA NAIK, w/o. Bhulan Sahani, s/o. Dasarath Naik, is my  
daughter-in-law. My son Bhulan Sahani and his wife reside  
together with my younger daughter Supriya Sahani w/o.  
Nohan Chauhan, separately at a rental house which is  
few meters away from my house.

2) That my aforesaid daughter-in-law is a hot minded, uncultured  
and rude in behaviour. She always has the tendency to  
engage in quarrel in petty things with my son and me.  
In fact, she gets support from her paternal family members  
especially, her mother who all are my neighbours.

3) That on 02.08.2023 at about 11:30 P.M. my aforesaid younger  
daughter rang me up in my mobile phone in a state of  
fear, asking me whether Bhulan came at my house. When  
I asked her what has happened, she informed me that  
Bhulan's life is in danger. His in-laws namely ① KAJARI  
NAIK w/o. Dasarath Naik (mother-in-law) ② SITA NAIK (sister-  
in-law) ③ PUTA NAIK (sister-in-law), both are daughters of  
Dasarath Naik, ④ KAJRU NAIK s/o. Dukaowon (maternal uncle  
in-law) ⑤ Unknown w/o. Kajru Naik (maternal aunt in-  
law) and his wife ⑥ GETTA NAIK w/o. Bhulan Sahani, all  
came to attack Bhulan Sahani for no reason. I and my  
elder daughter suddenly rushed at my son's rental house.

After reaching there, I saw all of them present. When I asked  
them the reason for their anger, they started falsely alleging  
that my son quarrels with his wife and we have come  
to beat him to death. When I requested him to cool down  
they became furious and started to brutally assault  
me and my elder daughter on our persons. It is fact  
that my elder daughter is two months pregnant which  
they knew very well but they intentionally assaulted  
us. I cried out loud to leave my daughter but in vain  
I anyhow rescued my daughter. Now my daughter  
is in serious condition and has been admitted to  
N.B.M.C. & H.

I therefore, request you to kindly take necessary legal  
steps against the abovementioned culprits and thus obliged.
