SUBJECT:- F.I.R against my Father-in-law, namely Narayan Das.

Respected Sir,

I, **Smt. Upasana Dutta**, (M). 8637-370562 / 988-3846339, W/O, Sri. Tinku Das, D/O, Sunil Dutta, aged about 34 years, Hindu by religion, housewife by occupation, resident of South Bharat Nagar, P.O & P.S: Siliguri, District: Darjeeling ,begs to report you the following facts:-

1. That I am submitting this FIR against my father-in-law Sri. Narayan Das, S/O, Lt. Budhya Das, resident of Dakshin Bharat Nagar, Ambika Chakrabarty Sarani, ward no. 24 under S.M.C, P.S: Siliguri, District: Darjeeling for the offences committed by him as stated below:-
2. That Since after my marriage with my husband Sri. Tinku Das , me and my husband were living/ residing at my in-laws house at Dakshin Bharat Nagar, Ambika Chakrabarty Sarani, ward no. 24, under S.M.C , P.S: Siliguri, District: Darjeeling . After coming to my in-laws house, I found that my father-in-law was brutally physical assaulted upon my mother in law, Smt. Manju Das (now deceased), sometimes, me and my husband have/had saved of my said mother in law from his hands/clutches. Moreover, me and my husband staying/living at first floor of my said matrimonial house (address as stated above) but on the other hand, my parents in law living at ground floor of my said matrimonial house.

It is pertinent to mention here that, my said father in law was committed/engaged extra marital affair with various unknown lady mostly those lady belongs to prostitutes/call girls, thus, most of the times, he came to my said matrimonial house at late night with various unknown ladies. When me and my husband and me and my younger sister in law (nanad) namely Smt. Munmun Das raised question with very surprisingly toward my said allege father in law then he told us that they are all of true love and he treated themselves as his paramour, as a matter of fact, my Father-in-law gave sexual offer towards our maid servants which me and my husband had / have hired at that point of times.

3. That said Narayan Das used to lots of vulgar and abusive words towards me and my said younger sister in law (Nanad). Moreover, he casted lustful, sensual and sexual evil look and eye upon his own daughter namely Smt. Munmun Das. (my said younger sister in law). Several times, he gave her as sexual offer and tried to molest her but any how she (my said younger sister in law) saved herself from his such action. She is very shameful/distress/trauma for doing such heinous acts and activities of her own father (said Narayan Das), being a own biological father, she never accepted for this type of wrongful acts of her own father. She did not agree to his such sexual offer and as she told him that she would disclose his such acts and activities to all, so, he continuously tortured herself both physically and mentally. It is pertinent to mentioned here that, her mother always tried to resist/strongly oppose against his such illegal acts upon my said younger sister in law (nanad), during that period, me and my husband also protested /stopped

against said my alleged father in law for commission of such heinous offence but he use to physical assault upon me and my husband by hired goons.

4. That on 18/05/2020 at 7.30 p.m at night after hearing of crying of my mother- in -law, then me and my husband came to my mother in law and asked her about the matter. On being asked my mother in law stated that my said allege father in law fell down on the ground after pulling hair and assaulted to her with fist and blows and also kicked. After few minutes, my mother in law was feeling illness. Seeing that my husband along with my said younger sister in law and other relatives shifted my mother in law to Siliguri District Hospital for treatment, when the attending doctor declared death. Based on I.C, Siliguri P.S register a specific case; vide Siliguri P.S Case no. 628/20 dated 19/05/20, U/S- 498 A /304/34 I.P.C and my said allege father in law was arrested and he was in behind a iron bar since the said specific date. But few months ago from now, he was got Court bail. After bail, he came to my said matrimonial house and at present moments, his such criminal activities has been increasing by lips and bounds in my entire family members which is a clear cut threat of our safety and security in my said matrimonial house .
5. That on 27/07/23 my said allege father in law came to my said matrimonial house with one lady ,namely, Alaka Adhikary, as much as, this mischievous lady is a erstwhile maid servant in my matrimonial house and she was doing illicit relationship with my Father-in-law at that time, moreover, Alaka Adhikary is a direct involved to my Mother-in-law's death incident and told that he is in his life and further delivered loud voice as purports that he never deserted/leaved from such lady, thereafter, me

and my husband peacefully opposed/resisted such illegal activities of him then suddenly, some unknown miscreants have/had entered and physical assaulted upon me and my husband at that time, so, I was very scared and I called to my said younger sister in law (Nanad) and she came with very quickly, then my said father in law brutally physical assaulted upon my said sister in law in presence of me and my entire family members.

6. That on last night, i.e., on 03/08/23, at about 12 p.m (at night) suddenly knocked the main door of my house, while I and my said husband (details as stated above) ,subsequently, I opened the door then afore-said Narayan Das and his hired goons had/have entered my house and suddenly assaulted me and said hired goons of him, disrobed me, indeed, they touched my breast and caught my different sensitive parts and outraged my modesty, therefore, when my said husband was trying to protect /save me then my said allege father-in-law with the help of his hired goons used to physical assault upon his own son in front of me. It is pertinent to mention here that my father-in-law took Rs. 20,000/- (Rupees Twenty Thousand) from under the quilt of my bed(where I kept the same) ,however, I received severe injuries on my respective persons for such assault upon me. At that time, I screamed and then my allege father-in-law and his hired goons went away from there, but before leaving the spot, they gave a open threat warning that they will again come into my house, and murder me and my said husband if, I will lodge any complaint about the above-noted incident before any Police or concern authority against my said father-in-law.

For that reason, me and my said husband have been living/residing at my said matrimonial house (details as stated above) with lots of fear and anxiety and triggering trauma yet and we are suffering extremely bodily pain in our respective body persons.

7. That there are so many direct evidences ageist said my father in law (Narayan Das) in the said incident.
8. That please take initiate a Specific Case against said Narayan Das, so that, he will be arrested, so that then stop his such type of wrongful acts ,which is continuing / sustaining in my said matrimonial house and may not be release on bail after arrest of my said allege father-in-law in that case and the trial of his case is held as custody trial.

PRAYER

I, therefore, request you to kindly take necessary steps to initiate a specific case against said Narayan das and also take proper investigation, so that he may be punish by capital punishment for such offences committed by him for ends of administration of Justice.
