In utter dismay and agony, I, Sri Subhajit Sakhari, Son of Sanjit Sakhari, Resident of Rabindra Sarani, Ward No. 22 under Siliguri Municipal Corporation, Post Office - Rabindra Sarani, Police Station - Siliguri, District - Darjeeling, Pin - 734006 would like to bring to your kind notice that on 27.07.2023 (Thursday) while I was returning from Gosto Gopal More towards my home in my scooty at around 12:45 am in the night, near Siliguri Girl's School my scooty met with an accident and I was severely injured due to the said accident no third party was harmed in it though, I sustained severe injury in my head which caused me to blackout at that moment. I was retrieved and was brought back to senses by some local by-passers. Those people recovered me from the said situation and helped me to regain my consciousness. After regaining consciousness when I was looking for my belongings I realized that my gold chain was missing from my neck and cash in my wallet was also missing which amounts to Rs. 2,000/- (approx).

That it is being highly suspected by me that some miscreants might have taken the opportunity of me being in a vulnerable state and has robbed me.

Sir, I was in severe pain and mental agony because of which I could not lodge the complaint which explains the delay in the complaint. Stating that, I plead before your good office to take cognizance of the matter and initiate necessary investigation against those unknown miscreants and help me find my belongings.
