Subj:- FIR against Shyamal Kumar Saha and Kaberi Saha for demolishing of Partition wall of My house building, occupying 3 (three) ft area illegally, stolen/plundering of cash, ornaments from my house and attacking on me with intention to death.

Sir,  
I beg to state that I am an employee of SSB and posted at SSB Falakata as a Dy Commandant. I have my own house at Mathi Sasoni Lane, Shivmulla, my wife with 2 children living there. My family was came to Falakata and the house was kept lock.

Shyamal Kumar Saha and his wife Kaberi Saha is adjacent neighbour of South side of my house.

There was a partition wall about 3' distance from my building wall in South side.

On 3/8/23 at about 1800 hrs I along with my wife reach to my above house and found that the partition wall of all three floor demolish by said South side neighbour and illegally occupy the area with all stores kept there like, wood, iron rod, bricks and other stores including the bricks of partition wall by taking advantage of our absence from home.

There after, on checking/searching of my living room in 1st floor it found that gold ornaments around - 10 toshi (10gm) and cash amount Rs. 2 lacs missing from my room. Some more valuable items also could not trace out till now. There is a door and window in South side wall of 1st floor, which became free to ingress in my living room when the partition wall demolished by said Shyamal K. Saha and he might have looted/stolen these precious things getting scope of free from any hindrance. Some more valuable things also missing and which need to assess yet.

Further, when I with my wife went to kitchen, it found that he has block my water supply line upto kitchen. When I engage to check the line, said Shyamal Saha and Kaberi Saha attack upon us (i.e. I and my wife) by throwing bricks and pieces of other construction materials through the window of my South side wall with shouting to threats to kill us (saying maro, maro, mere phelo salake aj sujan, ar keb asteparbene). By good grace, I and my wife manage to take shelter in safer place of my house, otherwise grievous hurt or death was definitive.

They did not stop at that, rather they started using slang language and said "ghorer baire app take ses kore deho".


Therefore, I request to you kindly investigate the matter, assess the damage caused and take appropriate legal action against Mr. Shyamal Saha and his wife and arrange to recover the stolen property and illegally occupied land portion at early phase.
