Sir,

With due respect, I am producing herewith 05 (five) arrested accused persons namely (i) Debayan Ghosal (24 yrs) S/O Koushik Ghosal of Deshbandhu Para near Dadabhai Club, Birendra Bhawan 3 rd Floor, PS- Siliguri, Dist.- Darjeeling (ii) Munna Paswan (26 yrs) S/O Late Rambalak Paswan of Tikiapara, Majdur Colony, PO+PS- Siliguri, Dist.- Darjeeling (iii) Ganesh Das (22 yrs) S/O Gobinda Das of dhubri Ward No 11, Bahadurtari, PO+PS- Dhubri, Dist.- Dhubri, Assam (iv) Manik Barman (24 yrs) S/O Netai Barman of Matigara Bhangapool, PO+PS- Matigara, Dist.- Darjeeling and (v) Md Abdul (38 yrs) S/O Late Aktar Ali of Matigara Biswas Colony, PO+PS- Matigara, Dist.- Darjeeling and the following articles under seizure :-

1. One iron made Sabol and one sharp cutting knife recovered and seized from the possession of accused Bebyan Ghosal (24 yrs) S/O Koushik Ghosal of Deshbandhupara near Dadabhai Club, Birendra Bhawan 3 rd Floor, PS- Siliguri, Dist.- Darjeeling.
2. One Sharp cutting iron made knife recovered and seized from the possession of accused Munna Paswan (26 yrs) S/O Late Rambalak Paswan of Tikiapara, Majdur Colony, PO+PS- Siliguri, Dist.- Darjeeling.
3. One sharp cutting weapon called as "HASUA" recovered and seized from the possession of accused Ganesh Das (22 yrs) S/O Gobinda Das of dhubri Ward No 11, Bahadurtari, PO+PS- Dhubri, Dist.- Dhubri, Assam.
4. One sharp cutting steel made knife and one torch recovered and seized from the possession of Manik Barman (24 yrs) S/O Netai Barman of Matigara Bhangapool, PO+PS- Matigara, Dist.- Darjeeling.
5. One sharp cutting weapon called as "Bhojali" & one torch light recovered and seized from the possession of accused Md Abdul (38 yrs) S/O Late Aktar Ali of Matigara Biswas Colony, PO+PS- Matigara, Dist.- Darjeeling.

I, ASI Pema Dorjee Sherpa of Matigara PS, Siliguri Police Commissionerate beg to state that on 05.08.23 at 01.15 hrs received a reliable secret source information that a gang of miscreants assembled at Near Old Matigara Railway Station under PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Khaprail More area under Matigara PS. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No -309, Dated 05.08.23 and informed the fact to Officer-In-Charge, Matigara PS, SPC. As per his kind order and direction myself along with ASI Dhirandra Nath Mandal, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/974 Mintu Sen, CV-977 Ganesh Paswan and CV/643 Animesh Roy all of Matigara PS, SPC left for Near Old Matigara Railway Station under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input.

I also informed the fact to Night RT Van officer SI Chhabibal Singha and ASI Prabir Roy both of Matigara PS and directed them come at near Near old Railway Matigara Station to accompany with us. At 01.35 hrs we arrived at near Near Old Matigara Railway Station under PS- Matigara, Dist.- Darjeeling. After few time RT Van Officer SI Chhabibal Singha and ASI Prabir Roy along with force came at near Near Old Railway Matigara Station under PS- Matigara, Dist.- Darjeeling and accompany with us.

At about 01.55 Hrs as indicated by the source we noticed that 10/12 persons assembled in a dark place at Near old Matigara Station and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 05 (five) of them with deadly weapons in their possession but 05/06 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their


...es were assembled there and making preparation for committing dacoity in a house at Khapraill More area. On
...ch the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted
weapon from their possession under proper seizure list and arrested them under proper memo of arrest and observing
all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 05.08.23 in
between 02.45 hrs and 03.57 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section
of law may kindly be started against the above noted 05 (five) arrested accused persons namely i) Bebyan Ghosal
(24 yrs) S/O Koushik Ghosal of Deshbandhupara near Dadabhai Club, Birendra Bhawan 3 rd Floor, PS- Siliguri,
Dist.- Darjeeling (ii) Munna Paswan (26 yrs) S/O Late Rambalak Paswan of Tikiapara, Majdur Colony, PO+PS-
Siliguri, Dist.- Darjeeling (iii) Ganesh Das (22 yrs) S/O Gobinda Das of dhubri Ward No 11, Bahadurtari, PO+PS-
Dhubri, Dist.- Dhubri, Assam (iv) Manik Barman (24 yrs) S/O Netai Barman of Matigara Bhangapool, PO+PS-
Matigara, Dist.- Darjeeling and (v) Md Abdul (38 yrs) S/O Late Aktar Ali of Matigara Biswas Colony, PO+PS-
Matigara, Dist.- Darjeeling and others 05/06 unknown persons and arrange for its investigation.


