Sir, I SI. Komal K. Roy of Panitanki Traffic
 Guard spe beg to lodge a written complaint
 that on 06.08.23. at around 1820 hrs. While on
 my duty at Pacei-Jau-More, found one (1) TOTO
 without any registration number. Stationed near
 Pacei-Jau-More, Padhan Road in such a way sto-
 ering the free flow of traffic and causing
 hindrance and danger to the general public and
 thus rebels.

Accordingly I detained the said TOTO and on
 being asked the driver disclosed his identity as
 Jabangri Alam (28) S/o Sumar Ali of Goal Jach, Asdar,
 Bada IS Chupra, Dist. Jhalpaigaon, Assam
 Nagar, P.O. Bhaktenaga Dist. Jalpaigam.
 Further on being asked to produce relevant
 documents in support of his claim of plying TOTO
 on Major Road. They failed to produce the
 same. There after I seized the said
 TOTO and arrested the said person under
 Section 41 Cr.P.C. in R/w the Case. After observing
 all rules and formalities.



Therefore I would request you to kindly stop a specific case in terms of section 188/283 IPC and also Section 7 of Law. as deemed fit against the said person with necessary action as applicable.
