Sub: F.I.R. against my husband Sri Ajay Rajak, my Mother-In-Law Smt. Saraswati Rajak, my Brothers-In-Laws namely Sri Sunil Rajak and Sri Sanjay Rajak, my Sister-In-Law namely Smt. Rinki Rajak for committing Mental & Physical Torture due to Demand of Dowry

Respected Madam,

With due regards, I, **SMT. SUNTA RAJAK**, Wife of Sri Ajay Rajak, Daughter of Sri Ramdeb Rajak, Presently residing at Baroduari, P.S. Narsachandrapur, Dist. Malda, would like to lodge this written complaint to the effect that my marriage was solemnized on 05.03.2021 with **SRI AJAY RAJAK**, Son of Late Sakalu Rajak, Resident of Kawakhari, Medical More, P.O. Sushruta Nagar, P.S. Matigara, Dist. Darjeeling, according to Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house as mentioned above. It is to be mentioned here that our marriage was a negotiated marriage and at the time of negotiation of our marriage, my husband and his family members have placed some demands before my parents and considering my future conjugal life, my parents have given so many valuable articles as Stridhan Properties like golden ornaments, furniture & fixtures, utensils and other household articles including cash a sum of Rs. 3,21,000/- only out of which, Rs. 1,00,000/- only transferred to the Bank Account of Sri Aman Kumar Singh who is the friend of my husband and remaining amount of Rs. 2,21,000/- only was paid in cash to my husband and his family members as per their demand, in presence of our relatives and guardians and still now, all my aforesaid Stridhan Articles are lying the custody of my husband and in laws members.

After our marriage, my husband brought me at my matrimonial house as mentioned above, where we started to live together as husband and wife and in my matrimonial house, besides myself and my husband, my Mother-In-Law, two Brother-In-Law as well as their wives have also used to reside.

Immediately after few days of our marriage, my husband flatly refused to cohabit with me on the plea that he doesn't like me and my complexion is dark and he also stated that he is not at all interested to lead conjugal life with me as he never treated me as his legally married wife and he just married me due to the constant pressure of his family members and in reply, when I told him that before negotiation of marriage, you along with your family members have visited in our house to meet with me and the marriage was negotiated after obtaining proper consent from your side and at that point of time, why you have not urged before your family members that you doesn't like me and hearing the same, he became furious and started to commit mental and physical torture upon me. Thereafter, my husband in conspiracy with his other family members as mentioned aforesaid, have started to cause tremendous pressure upon

me to bring more dowry from my parental house and when I failed to bring money as per their demand, they have increased their torture upon me both mentally and physically. They did not provide sufficient food to me and even during my illness, they did not bother to take me before the Doctor also. They treated me just like a maid servant and forced me to do all the household chores in my matrimonial house and I being a newly married wife, used to do all the household chores in their house as per their direction with a hope that in future, they will definitely realize their own mistake and thereby, rectify themselves but all my hopes have gone in vain due to their continuous torture upon me.

Later, I came to learn that my husband has been maintaining an illicit and adulterous relation with a woman and the said fact are very much within the knowledge of every family members of my matrimonial house and inspite of having knowledge about the said illicit and adulterous relation of my husband with another lady, they have negotiated the marriage of my husband with me by suppressing the said facts and for which, my husband has shown less interest to make physical relation with me and when I raised objection against their said illegal acts and activities, my husband in conspiracy with his family members, have threatened to kill me if I inform the matter to anybody.

Due to their constant physical and mental torture upon me, I have compelled to inform the same to my parents and after knowing the said facts, my parents and other relatives have also intervene into the matter and requested them not to inflict any kind of torture upon me but they did not pay any heed to their request and on contrary, they continue their said inhuman torture upon me both physically and mentally.

On 18.12.2022, my husband and in laws members in order to destroy my life, inflicted physical torture upon me without any just cause and reason and finding no other alternative and also in order to save my life from their hands, I have informed the matter to my parents and immediately after receiving the said information, my parents and other relatives have visited at my matrimonial house and recovered me from their hands and finding no other alternative, I have compelled to leave my matrimonial house with my parents in a single wearing apparels leaving my entire jewelries and other stridhan articles in my matrimonial house and since then, I have been residing at my parental house at Harischandrapur, Malda.

Previously, I did not lodge any complaint against my husband and in laws members considering my future conjugal life with my husband and during my stay at my parental house, my parents and relatives have made several attempts to reconcile the matter amongst us but in vain and finally, I have filed one application U/S - 125 of Cr.P.C. before the Ld. A.C.J.M. at Chanchal, Dist. Malda and after hearing, Ld. Court was pleased to issue summon/notice upon my husband but after receiving the notice from the Ld. Court, my husband and my in laws members have asked us to visit at my matrimonial house in order to discuss the matter and also to settle the disputes amicably and after receiving such type of assurance from them, myself and my family members and other relatives have visited at my matrimonial house in order to overcome the said situation but immediately after reaching at my matrimonial house, they again started to misbehave with me and my parents and also threatened

me and my family members with dire consequences and they have clearly stated that they will not allow me to enter into my matrimonial house as my husband is not ready and willing to lead further conjugal life with me and also threatened me that if I try to enter into my matrimonial house, they will not hesitate to ruin my life and property permanently and hearing the same, when I asked and requested them to return back my jewelries and other articles, my mother-in-law became more furious and started to assault me physically in presence of my parents and other in laws members and finding no other alternative, I have compelled to leave my matrimonial house again with my parents and other relatives in order to save my life from their hands and took shelter at my parental house.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against my husband and other in laws members as mentioned above, according to the provision of law and obliged thereby.
