1. That I got married with Bishnu Gupta son of Dilip Gupta on 29th June 2020 at Sardha Hotel, Mallaguri, Siliguri, our marriage was arrange marriage solemnize by following Hindu rites and customs
2. That after our marriage my husband took me to my matrimonial house which is situated at Lodhabari, Banchhabita P.O. & P.S. Kharbari, Dist- Darjeeling, in the state of West Bengal.
3. That at the time of marriage my mother and other relatives provide cash sum of Rs. 61 Thousand, valuable household articles, furniture, utensils, gold ornaments as "stridhan" as per their dowry demand.
4. That after few days of our marriage my husband including in-laws pressurized me to bring more cash and gold ornaments from my paternal house, after denial they started torturing me both physically and mentally
5. That my in-laws always treated me as servant at the same time I was never given access to the Temple of my matrimonial house. They always restricted my movements inside my matrimonial house and also impose restriction to go out side and to visit my parental house.
6. That from 28th June 2023 my Mother in-law and Sister in-law strictly stated me to bring cash of Rs. 2 Lakh on refusal they threatened that they will kill me on informing about the same my Father in-law replied that if I die he will not even come to see my body and contentiously they assaulted me physically for one week.
7. That then on 4th July, 2023 late night my Father in-law and Mother In-law started abusing me with filthy languages without any reason my husband also shouted on me and said me go and die the situation became unbearable to me and finding no other alternatives, I intake Phenyl on 5th July 2023 at around 5am early morning after that I was unconscious than I was taken to the Khorbari Gramin Health Center by me Father & Mother in-laws.

They left me suffer there and subsequently after analyzing my deteriorating health condition the hospital authority referred me to the North Bengal Medical College & Hospital (NBMC&H). The concerned authority of NBMC&H contact my parents and informed them about my health condition. After that my parents rushed to the NBMC&H and considering my health condition and for my better treatment they shifted me to Ramkrishna Seva Sadan at Bidhan Road, Siliguri. I was admitted on 5th July, 2023 to 8th July, 2023 and the doctor advised me to take totally bed rest at list for 3 weeks. That on several requests made by my mother and well wishers to my father in law namely Dilip Gupta, mother in law namely Bharti Gupta, brother in law namely Sanjay Jaiswal, sister in law Dipa Jaiswal for amicably settled the disputes between us but they did not paid any attention. Upon continuous calls from my parents finally my husband came to settle the disputes on 20th July, 2023 and during discussion suddenly my husband became very arrogant and started abusing us with filthy languages and directly denied to take me back with him in front of well wishers and after protest above named in-laws threaten us if I go back with them they will kill me or we face dire consequences and my husband assaulted me with hand pushed my mother and left the house while abusing.

Therefore my humble request to you take an immediate action against the above noted persons for the ends of justice.
