Sub: Written Complaint against PARIMAL KUMAR DUTTA, Son of Suresh Chandra, DEBASISH DUTTA, Son of Parimal Kumar Dutta, DEEP RAJ DUTTA, Son of Parimal Kumar Dutta, all are residing at Suryasen Colony, Block - A, Ward No.34 of S.M.C., Siliguri, P.O. - Siliguri Town, P.S. - New Jalpaiguri, District - Jalpaiguri, PIN - 734004 and their Manager - one RAJU and their men andagents.

- I, Sri Anil Kumar Agarwal, Director of Amrit Vyapaar Private Limited, Having its Office at M.L. Agarwala Building, Church Road, Siliguri, P.O. and P.S. Siliguri, District Darjeeling, PIN 734001, would like to bring to your kind notice the following facts for consideration and necessary action.
- 1. That Amrit Vyapaar Private Limited is the sole, absolute, exclusive and recorded owner in possession of all that piece or parcel of land measuring 3.64 Acres forming part of R.S. Plot No.63 corresponding L.R. Plot No.64 and 2.00 Acres forming part of R.S. Plot No.75 corresponding to L.R. Plot No.77, in total measuring 5.64 Acres, recorded in R.S. Khatian No.328/1, 328/5 and 328/11 corresponding to L.R. Khatian No.1843, situated within Mouza Binnaguri, R.S. Sheet No.12 corresponding to L.R. Sheet No.12, J.L. No.03, P.S.- New Jalpaiguri, in the District of Jalpaiguri, having permanent heritable and transferrable right, title and interest therein. That Amrit Vyapaar Private Limited has built a pucca boundary wall and a structure around and on the aforesaid land. That Amrit Vyapaar Private Limited has been enjoying, occupying and using the aforesaid land freely, openly without any interruption from anyone whatsoever and is in unfettered physical possession of the same. That it is pertinent to mention here that the name of Amrit Vyapaar Private Limited has been recorded in the L.R. Record of Rights on the strength of the order dated 06.06.2023 passed by the Ld. A.D.M & D.L. & L.R.O, Jalpaiguri vide Appeal Case No.XIII-B/07 of 2023.
- 2. That surprisingly, on 01.07.2023, the abovenamed miscreants along with their men and agents, forming an unlawful assembly, resorted to harass and disturb the peaceful possession of the Amrit Vyapaar Private Limited in respect of the aforesaid land. The abovenamed miscreants along with their men and agents tried to trespass into the aforesaid land without any authority but with the intervention of the personnel, employees and staffs of Amrit Vyapaar Private Limited and the local people, the said miscreants and their men and agents fled from the aforesaid land. That in the evening of 02.07.2023, the said men again tried to dispossess Amrit Vyapaar Private Limited from the aforesaid land. Finding no other alternative, Amrit Vyapaar Private Limited approached the Ld. Executive Magistrate at Jalpaiguri under Section 144 of Cr.P.C. vide Ptn./R./ No.412/2023 and the Ld. Court was pleased to pass an order on 03-07-2023 directing that Amrit Vyapaar Private Limited is not disturbed by the abovenamed miscreants.

- 3. That it is pertinent to mention here that abovenamed Parimal Kumar Dutta had also approached the Hon'ble LRTT at Kolkata vide O.A. 2095 of 2023 challenging the order passed by the Ld. A.D.M & D.L. & L.R.O. Jalpaiguri in Appeal Case No.XIII-B/07 of 2023. The Hon'ble Tribunal was pleased to dismiss the matter vide order dated 21-07-2023.
- 4. That even after tasting defeat before the Hon'ble LRTT at Kolkata, the abovenamed miscreants did not refrain themselves from disturbing the peaceful possession of Amrit Vyapaar Private Limited.
- 5. That subsequently, abovenamed Parimal Kumar Dutta filed a civil suit being T.S. No.428 of 2023 against Amrit Vyapaar Private Limited before the Court of the Ld. Civil Judge (Junior Division) at Jalpaiguri. The Ld. Court vide its order dated 25-07-2023 was pleased to reject the prayer of abovenamed Parimal Kumar Dutta.
- 6. That despite failing before the Ld. Courts, Authorities, Forums and Hon'ble Tribunal, abovenamed Parimal Kumar Dutta, his sons Debashish Dutta and Deep Raj Dutta, their men and agents are disturbing the peaceful possession of Amrit Vyapaar Private Limited over the aforesaid land inspite of them knowing fully well that they do not have any right, title or interest of any nature in the aforesaid land. That lastly in the early hours of the morning of 02.08.2023, the abovenamed Debasish Dutta. Deep Raj Dutta and Raju alongwith 15-20 men damaged the boundary wall of the aforesaid land and have attempted to encroach upon and grab the aforesaid land. The said miscreants have broken the lock of the gate of the aforesaid land and dismantled the iron pipes and other building material of Amrit Vyapaar Private Limited. Several goods and building material of Amrit Vyapaar Private Limited that were stored upon the said land are missing. The abovenamedmiscreants have no regard for the orders passed by the Ld. Courts, Authorities, Forums and Hon'ble Tribunal. They are desperate in nature and we are under apprehension that they will undertake acts not permitted under the law to grab our land forcefully on the strength of their muscle power.
