Respected sir,

I, Om Prakash Gupta, S/o Lt. Ramnath Prasad Gupta, Resident of Tinbatti More, Sripally, Opp. More Service Petrol Pump, P.O. Siliguri Bazar, P.S. N.J.P, Dist. Jalpaiguri - do hereby lodge this F.I.R to the effect stating that today on 02-08-2023 at about 8:45 AM when my younger son namely Shubham Gupta, aged about 18 years (he is a student of Siliguri College) return home after purchasing milk, he saw that Anil Gupta, Piyush Gupta both are sons of Sri Jay Prakash Gupta and Munni Devi Gupta, W/o Jay Prakash Gupta, All are resident of C/o J.P Printers, Tinbatti More, Opp. Teesta Office Gate No I, Ward No. 31 of S.M.C, P.S. N.J.P, District. Jalpaiguri, these three accused persons were quarreling and insulting my wife using filthy languages and also attacked with stone as a result my wife got injury in right leg and for that reason my younger son asked those accused persons as to why they are quarreling with my mother by using filthy languages and at that time those accused persons started to physically assault my younger son by feets and blows resulting in serious injury to my younger son as well as cut and injury on my younger son lower lips and as well as resulting in blood from my younger son nose due to blow on my younger son nose. They torn my said son's T shirt also. Thereafter my younger son felled down on the ground and then one of the accused persons namely Anil Gupta caught hold of my younger son's neck with intention to kill my younger son by strangulation. He was having Rs. 800/- in his pocket from his pocket. I also state that my wife is mentally unfit and at that time me and my elder son were not at home. So taking this opportunities, the accused persons intentionally took of quarrel with my wife knowing fully well that my younger son will come to rescue my wife and finding my younger son alone, the accused persons will kill him. People of locality came listening of crying of my younger son and at that time accused persons flew from the spot. Hearing this incident, I rushed at home and took my younger sons to Siliguri District Hospital for treatment.

So. I pray before you to take necessary legal action against all the accused persons namely Anil Gupta, Piyush Gupta, and Munni Devi Gupta so that they cannot do the same in future.
