Sub: Theft of valuables and other household items at residence

Sir,

This is to bring to your notice and request attention, as there has been theft of household items and certain tentative valuables at my residential property at 60, Rabindra Chatterjee Road, Hakimpara, Ward #16; Siliguri.

Our residence was vacant for last 1 month as both of my parents, who are the permanent dwellers at this said property, had been in Mumbai owing heart ailment. They are under treatment in Mumbai for last 1 month.

The theft had taken place last night when the miscreant/s broke entered our house main door adjacent to rooftop open area. I was intimated by the neighbours today morning and have rushed in. The rooms, while entered today in presence of police personnel, was found all scattered with various items and floor fully flooded with water. This has created a panic situation with my elderly parents who are due to return here in next 15/20 days time. I am deeply worried as to their security and at the same time caught badly with the loss of all the items.

Provided underneath is the list of items found lost and would solicit your needful action in this regard. Needless to mention that, it has created a cause of worry for the people in the neighbourhood.
