Subject: Filing a Report Regarding Missing Helper and Stolen Valuables

I am writing to officially file a First Information Report (FIR) regarding an incident that occurred at my residence on 09/08/23. I would like to bring to your attention the details of the incident for appropriate investigation.

On the morning of 09/08/23, at approximately 8:30 AM, our recently employed household helper, Bella Bada, age -23, who was from Indung Tea garden, left our residence without providing any prior information or notice. Upon realizing her abrupt departure, we observed that she had taken her personal belongings, including her clothes. Upon further inspection, we discovered that our locker, which was not locked at the time, had been accessed.

We have reason to believe that during her departure, Bella Bada took valuable items from the unlocked locker. Specifically, a gold haar (jewellery pendant), a chain, and a bracelet are missing from the locker.

We kindly request your immediate attention and action in investigating this incident. We understand the importance of the situation and hope that appropriate steps will be taken to recover the missing items and address the matter accordingly.
