In producing herewith one accused person named Santosh Sah (35y/M), S/O. Rajendra Sha of New Pokiajote, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

Fifteen (15) bottles of Himalayan Gold 60 UP, each bottle containing 600 ml, each bottle MRP-155 rupees (Total 9.0 liter) out of which one has been taken as sample for examination.

I, ASI Manoj Kumar Roy of Pradhan Police Station under Siliguri Police, Commissionerate would like to lodge this written complaint against one accused person named Santosh Sah (35y/M), S/O. Rajendra Sha of New Pokiajote, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 09.08.2023 at 18.35 hrs. received a source information that one person has been selling huge illegal liquor at his shop styled as Subham Hotel under Pradhan Nagar Police Station without any valid license. Accordingly, I informed the matter to I/C PS and as per his kind direction I along with CV/128 Ajay Sahani, CV/645. Pankaj Gupta and CV/223 Swapan Chettri (All of Pradhan Nagar Ps) had been to Subham Hotel under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that above noted person has been selling illegal liquor at his shop styled as Subham Hotel.

Subsequently, I along with my force able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were found in his shop. On demand he failed to produce any valid license/papers for storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last six months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above-mentioned person named Santosh Sah (35y/M), S/O. Rajendra Sha of New Pokiajote, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.40 hrs to 20.05 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Santosh Sah (35y/M), S/O. Rajendra Sha of New Pokiajote, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
