I ASI Subash Bdr. Tamang of Matigara P.S do hereby lodge a written complaint to the effect that on 08.08.2023 at 22:05 hrs I received a information from reliable source that one vehicle bearing Reg. No. WB - 73 C 6589 being loaded with stolen river bed materials coming from Baalson Ghat side . On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at near Balason Ghat under Matigara P.S area, I found one vehicle bearing Reg. No. WB - 73 C 6589 loaded with river bed materials going towards Shivmandir. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area.

As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle bearing Reg. No. WB - 73 C 6589 under proper section of law and arrange for its investigation.
