আমি শ্রীমতি বিনাকা স্বর্গকার দাস, স্বামী অমিল দাস, সন্তান - মাতঙ্গিনী কলোদী-১, টিনাচাপাড়া, বর্ডার নং-২৮ (এস এম সি), ঘনত - শিলিগুড়ি, জেলা - দার্জিলিং, এতদ্বারা আপনাকে জানাইতেছি যে, পরকাল মঙ্গলবার, ইংরেজীতে ০৪-০৪-২০২৩ তারিখে আনুমানিক দুাত সাড়ে সপটার সময় আমি বাওয়া-নাওয়া করে বাড়ির পাশে রাখায় প্রতিনিয়ত হুটামলা করি, তালতু ভাই করেছিলাম। ত্রিক সেই সময় ছুটায় করে (১) অতিক্রম সরকার, পিতা ইন্দ্রমোহন সরকার, (২) অজয় দাস, পিতা জ্যোতিস দাস, (৩) প্রসেনজিৎ বর্মন, পিতা সৌমেন বর্মন, হাইকে করে সেখান দিয়ে যাচ্ছিল, এরা আমাদের পাড়াতেই থাকে। অতিক্রম সরকার তার হাইকটি আমার হাতে লাগিয়ে দেয়। এর প্রতিবাদে আমি ওকে বলি কি করে হাইক ঢালাস, সেখে ঢালানি তো, তখন অতিক্রম সরকার আমায় বলে ভালো করেছি। এরপরে গায়েব উপর দিয়ে পাড়ি নিয়ে যাবে, তারপর আমি বলি যে, হাঁড়া আমার বাড়ির লোককে ডাক দিয়ে আমি, তখন তারা পাড়ির থেকে নেমে আমার হাত ধরে টান দেয়, তুকে হাত নিয়ে নাইটি টান নিয়ে ছিড়ে ফেলে। তখন আমি বুঝতে পারি তিনজনেই মদ্যপ অবস্থায় আছে। আমাকে আরো অনেক নোহো পালাপালি দেয়, বলে যেখানেই পাব, সেখানেই তোকে সেখে সেব আমাদের কিছু করতে পারবে না। তখন কোনভাবে আমি দৌড়ে বাড়ি ঘাই এবং বাড়ির সবাইকে ডাকি, ওরা তখন পালায়। আমাকে আর আমার বরকে মেরে ফেলার হুমকিও দেয়। এর আপেও আমাকে সেখে অনেক নোহো কথা বলেছে, তাত কিছু বলিনি, কিন্তু ওরা আমার সঙ্গে এমন ব্যবহার করবে, আমি ভাবতেও পারিনি। এইভাবে তো আমি আর বাড়ির থেকে বের হতে পারবো না।
