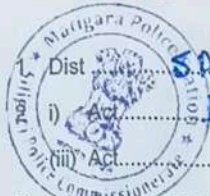

Sir,

With due respect in producing herewith one seized vehicle bearing Reg. No. WB 73 E 4025 partially loaded with river bed materials, I ASI Aibul Islam of Matigara P.S, SPC lodge this Complaint against the driver/owner of the vehicle bearing Reg No- WB 73 E 4025 to the effect that on 10.08.2023 at 11:30 hrs onwards in course of Mobile van duty I received a specific information that illegal mining is going on at Tarabari Ghat under Matigara PS area and transporting by a tractor. Accordingly myself along with force went to the Tarabari Ghat under Matigara PS, SPC, and found that one vehicle bearing Reg. No WB 73 E 4025 partially loaded with riverbed materials and illegal mining is going on at Tarabari Ghat. As soon as myself along with force reached near the vehicle at Tarabari Ghat the driver of the vehicle fled away leaving behind the partially loaded vehicle. Then I tried to search the driver/owner of the vehicle but in vein. Then I seized the vehicle bearing Reg. No. WB 73 E 4025 under proper seizure list after observing all formalities. Seizure was made between 12:20 hrs to 12:35 hrs and brought the vehicle at PS compound.

Therefore I pray before you a specific case may kindly be started against the driver /owner of the vehicle bearing Reg. No. WB 73 E 4025 for illegally mining and transporting of riverbed materials, under proper section of law and arrange for its investigation.
