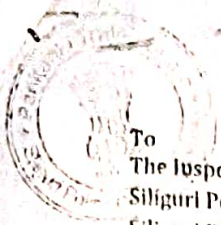

Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Kachari Road, Hospital More without any valid documents causing obstruction to public way.

Sir,

I ASI, Rajat Kr. Saha of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 09.08.23 at around 15.15 hrs, while on duty at Hospital More, Kachari Road area found one TOTO without any registration number stationed at Hospital More, Kachari Road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Mafijuddin (33 Yrs), S/O- Lukman Ali of Vill- Bairgach, Andharia, P.S-Karandighi, Dist-U/Dinajpur; A/P- Fuleswari Pipeline, NJP, Siliguri, Jalpaiguri. Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
