Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against present user Dilip Dey, Samar Dey and Bimal Dey, S/o- Lt. Durga Mohan Dey, A.T. Mukherjee Road By Lane, Near Usha Sewani School, Hakimpara, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 09.08.2023 at about 02:40 P.M. acting on a source information I, along with 1) Sri Amaçash Mahandeo, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other supporting staff of Mobile van entered the domestic premises of Dilip Dey, Samar Dey and Bimal Dey and inspected service installation, metering installation of Consumer ID 412151483 in the name of Lt. Shephali Dey. During inspection it was found that the electricity is being used illegally for domestic purpose by meter bypassing by direct taping from incoming service cable of energy meter. It is also noted that, the electricity is being used illegally by not registering the actual electricity consumption in the meter. During inspection it is also found that an excess load of 1.25 KW is being drawn unauthorisedly by meter bypassing.

As theft of electricity was detected the energy meter make Bentec Electricals & Elec Ltd, serial no.- IPD247196 installed against Con Id. 412151483 and approx 1 meter wire with tapping point intact seized by preparing a formal seizure list duly signed by Dilip Dey and witnesses, The copy of the seizure list handed over to the Dilip Dey and his signature obtained as token of receipt.

As Dilip Dey, Samar Dey and Bimal Dey has committed offence u/s 135(1)(a) of the Electricity Act 2003 by doing theft of electricity in the manner as stated above you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
