On 09.08.2023 at about 03.55 p.m. acting on a source information I, along with 1) Sri Amarasish Mahandeo, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the commercial shop (beauty parlour) of Souvika Mitra(Das) and inspected service installation, metering installation of Consumer ID 401456786 in the name of Souvika Mitra(Das). During inspection it was found that electricity was being used unauthorisedly & illegally by Souvika Mitra(Das) by reconnecting the disconnected service line of the metering installation that was disconnected previously on 05.01.2023 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Bentec Electricals & Elec Ltd, serial no.- B3806385 installed against Con Id. 401456786 seized by preparing a formal seizure list duly signed by Souvika Mitra(Das) and witnesses. The copy of the seizure list handed over to Souvika Mitra(Das) and her signature obtained as token of receipt.
