Respected Sir,

I, Sri Pradip Ghosh, Son of Late Bijoy Ghosh, aged about 51 years, Auto Driver by occupation, resident of Milanpally, Mukanda Das Road, Ward No. 25 of Siliguri Municipal Corporation, Post Office & Police Station Siliguri, District Darjeeling, would like to lodge this FIR to the effect that today, i.e. 09.08.2023 at about 01:00 a.m. I was plying by auto rickshaw for carrying passengers and reaching near Thana More, P.S. Siliguri, District Darjeeling, I parked by vehicle beside the road and halted for a while to carry passengers and my vehicle ignition was still on, then I slowly accelerated my Auto Rickshaw but suddenly a passenger City Auto vehicle (4 Wheeler), bearing No. WB-73F-6176, which was driven rashly by the Auto Driver namely, Sri Bappa Roy, Son of Bablu Roy, blocked my way. I then asked the driver for his negligent driving which could cause an accident and further requested him to move forward and clear the way. At that moment, the Driver of the said vehicle Sri Bappa Roy became furious and started to abuse me with slangs/filthy languages and said Sri Bappa Roy came to me and garbed by neck, then pulled me out of my vehicle and started to assault me with fists and blows. I any how tried to resist myself, but said Sri Bappa Roy pulled out a iron rod from his vehicle bearing No. WB-73F-6176 and hit my forehead with the said iron rod causing grievous injury leading huge blood loss, but he still did not stop and kept on hitting me with the said sharp edge end iron rod on different parts of my body. I also received cut injury on my left arm, backside of my head and other areas of my body, said Bappa Roy also grabbed my gold ring (weighing 4 to 5 grams approximately). Due to the said assault and huge blood loss I almost became numb and then the local people of the area came and rescued me from said Bappa Roy. I was then instantly taken to the Siliguri District Hospital, for treatment where 3(Three) stitches were done for the injury I received on my forehead and further medication was also given to me.

I, therefore, request you to kindly take necessary steps against the aforesaid culprit for his commission of such offences and help me to retrieve me my golden ring from him.
