**Subject: F.I.R**

Respected Sir,

I, Sombit Mukherjee, son of Late Moni Mukherjee, resident of Jote Shibrampur, Beledanga Club, P.S & P.O- Maheshtala, Dist- South 24 Parganas, Pin-700141, West Bengal, am writing to lodge a formal complaint against the Sabuj Sarkar, son of Basudeb Sarkar, resident of Bidhannagar, Sukanta Pally, Budharugaon, Chitalghata, Phansidewa, Dist- Darjeeling, PIN-734426, Prasenjit Roy, son of Nanigopal Roy, permanent resident of Paschim Duramari, Banarhat, Dist- Jalpaiguri, PIN-735233, presently residing at Mahakal Pally, Ward no-10, P.O & P.S- Siliguri, Dist- Darjeeling, and their associates.

On August 7th, 2023,(Monday) yesterday I traveled from Kolkata to Siliguri for work-related reasons. Following my arrival, I proceeded to Mathabhanga on the same day to conduct a meeting with my customers. The incident occurred today on 08/08/2023,(Tuesday) when I was in Mathabhanga for a business meeting with my customers. At around 12:30 p.m., while having breakfast at Lassi King, Near Sani Mandir, Mathabhanga, PIN-736146, I was forcefully approached by the above-mentioned individuals along with their associates. They physically assaulted me, forced me into their car with registration number WB02AQ3988, and took me in the Siliguri to a shop named Panorama at Pakurtala More, Siliguri. In the shop, I was subjected to further physical assault, and my mobile phone was taken from me. They forcibly snatched Rs. 20,000 from my pocket and Sabuj Sarkar unlawfully transferred Rs. 4,500/- from my mobile phone to his own account. Under duress, they coerced me into signing a white blank paper and even threatened me with a knife. This incident has caused significant distress, and I fear for my safety and well-being.

I would like to bring to your attention that I had previous business dealings with these individuals, and they currently have some of my AC machines in their possession. They have frequently made severe threats towards me in the past as well. Today evening, I sought medical treatment at Siliguri District Hospital.

I earnestly request that you take immediate and strong legal action against Sabuj Sarkar, Prasenjit Roy, and their associates for their criminal actions against me. I am in dire need of relief from this distressing situation and seek your assistance in ensuring that justice is served.

I am prepared to fully cooperate with the police investigation, Kindly treat this matter with the utmost urgency and sensitivity.

Thank you for your prompt attention to this matter.
