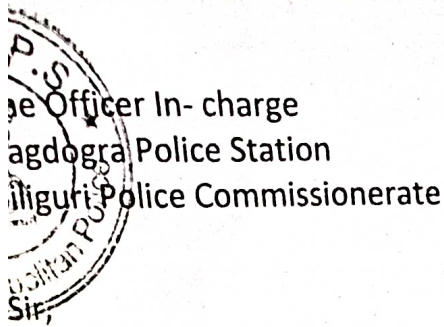

With due respect, In producing herewith one accused person namely Md Khairul (35) S/O- Lt. Md Mayar of Dhumgarh PO- Kantivita ,P.S- Phansidewa , Dist- Jalpaiguri under arrest along with seized cattle and seized vehicle :-

- (i) Three (03) numbers of buffaloes in different size and black color.
- (ii) One TATA ACE vehicle having registration No- WB-73-E-0703 which was used to carry the seized buffaloes SL. No. 1.

I, ASI Sadananda Debnath Of Bagdogra PS under Siliguri Police Commissionerate do here by lodged a written complaint to the effect that on 29.07.23 at 00-35 hrs I received a secret source information that some vehicles are being loaded buffaloes illegally and coming from Ghoshpukur side towards Siliguri side through Rangapani road without any valid documents/papers and if immediate action is taken , it can be apprehend . Accordingly, I share the information with O/C Bagdogra P.S and duty officer of PS and as per his direction myself along with C/851 Mahesh Mandal C/483 SK Abul Basar left for Rangapani Bazar to verify the veracity of information vide Bagdogra PS GDE No. 1362 dtd. 29.07.23. At about 01-35 hrs we reached at Rangapani Bazar and started upcoming vehicle checking on that road and on the basis of secret information at 04-35 hrs we intercepted the above vehicle i.e. One TATA ACE vehicle and apprehended the driver of the said vehicle. On checking the vehicle we found three buffaloes in different size and black color were loaded on the vehicle. On being asked the apprehended driver disclosed his name and address mentioned above which is not verified and stated that he was carrying these buffaloes from Ghoshpukur side to Oodlabari side for sale the same illegally . On asked, he failed to produce any valid License/ papers to carrying the said buffaloes in that vehicle and also failed to produce any papers in respect of the said buffaloes. On further checking it was found that there was no arrangement made for food and water for the Cattle as per govt. rules which he was carrying in that vehicle. Besides, this there was no sufficient space for the buffaloes in that vehicle and all of them were tied with ropes. The above noted driver of the said vehicle also failed to produce any papers/documents in support of the said vehicle. On further interrogation the above noted apprehended person confessed his guilt and also stated that this business is run by one Raju Roy S/o Lt. Ranjit Roy of Bhujipani PS Bagdogra , Darjeeling since long and accordingly to him, he was carrying the said buffaloes from Chater Hat , Ghoshpukur to Oodlabari for selling the same to his designation customers. Accordingly I seized the Three (03) numbers of buffaloes in different size and black color and said TATA ACE vehicle having registration No- WB-73-E-0703 which was used to carry the seized buffaloes under proper seizure list on search disinterest witnesses but could not found due to mid night and arrested the above noted accused person U/S 41 Cr P.C , informing him the grounds of his arrest as he is violation of The Prevention of Cruelty to Animals Act 1960. The seizure and arrest have been made in between 04-35 hrs to 05-45 hrs. The seized three Buffaloes handed over to the Fulbari Khowar for safe custody. The accused persons are violated The Prevention of Cruelty to Animals Act 1960.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the driver of vehicle No. WB-73-E-0703 namely (1) Md Khairul (35) S/O- Lt. Md Mayar of Dhumgarh PO- Kantivita ,P.S- Phansidewa , Dist- Jalpaiguri and (2) Raju Roy S/o Lt. Ranjit Roy of Bhujipani PS Bagdogra , Darjeeling to arrange for its investigation.
