surayasen colony blook ,P.S-Bhaktinagar , Dist-jalpaiguri ; . Further on being asked to produce
relevant documents in support of his claim of plying TOTO on Major Road he failed to produce
any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr.
PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above named
person (TOTO Driver) under proper section of law from your end.
