Sir,

In producing herewith 03 (three) arrested accused persons named (1) Mangal Ghosh (24) S/O Late Sunil Ghosh of Gowala Patty, ward No.04, PS- Siliguri, Dist-Darjeeling 2) Bijen Tamang (26) S/O Tshiring Tamang of Upper Swarni School, near Bus Stand, PS- Kalimpong, Dist-Kalimpong and (3) Santu Biswas (20) S/O Tapan Biswas of Natunpara Ramghat Ward No- 05, PS- Siliguri, Dist-Darjeeling along with seized articles (i) one knife measuring 13" including handle wrapped from the possession of Mangal Ghosh (24) S/O Late Sunil Ghosh which was kept concealed on the back side waist ii) One iron sword measuring 31" including iron handle recovered from the possession of Bijen Tamang (26) S/O Tshiring Tamang which he was holding on his hand and iii) One iron rod measuring approx 25" pointed one end recovered from the possession of Santu Biswas (20) S/O Tapan Biswas which he was holding on his hand under proper seizure list.

I, SI Mrinmay Ghosh of O/C Khalpara TOP Under Siliguri PS/ SPC do here by lodge this written complaint to the effect that on 11.08.23 at 30.45 hrs I received secret source information that 8-9 persons had assembled at Jhankar More Sabji Bazar, in front of Modern Boys Club ground, Ward No 04 to commit dacoity at the locality. Immediately informed the tip of information to O/C Khalpara TOP and as per his kind direction I, noted the fact in GD book vide Khalpara TOP GDE No.237 dated 11.08.2023 and he also communicate to the superior officer as per his kind instruction and verbal approval order myself along with ASI Uttam Kr. Dhar, ASI Kala Chand Singha ASI Raju Sarkar, C/541 Santosh Kr. Roy, C/1706 Tapan Debnath, C/174 Pradip Kr Das, C/1703 Suchandan Saha, CV-980 Ranjan Ojha left for Jhankar More Sabji Bazar, in front of Modern Boys Club to verify the veracity of the information. At about 01.15 hrs I along with police party arrived at the spot Jhankar More Sabji Bazar, in front of Modern Boys Club and after keeping our vehicle at a distant place we proceeded towards Jhankar More Sabji Bazar, in front of Modern Boys Club on foot and being indicated by the source found from the considerable distance that a gang of eight/nine persons were assembled at Jhankar More Sabji Bazar, in front of Modern Boys Club and they were whispering in very low voice and situation is dark and rainy Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase manage to apprehended 03 (three) persons and others persons fled away from the spot. On interrogation, the apprehended persons disclosed their name, address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with others assembled there in preparation to commit dacoity. They also stated that they also eight /nine their associates were assemble at the spot and they fled away from the spot. Accordingly on being search I recovered one knife measuring 13" including handle wrapped from the possession of Mangal Ghosh (24) S/O Late Sunil Ghosh which was kept concealed on the back side waist 2) One iron sword measuring 31" including iron handle recovered from the possession of Bijen Tamang (26) S/O Tshiring Tamang which he was holding on his hand and 3) One iron rod measuring approx 25" pointed one end recovered from the possession of Santu Biswas (20) S/O Tapan Biswas which he was holding on his hand .Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them in between 01:15 hrs to 01:45 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.




Under the above fact and circumstances I pray that a specific case may kindly be started against
