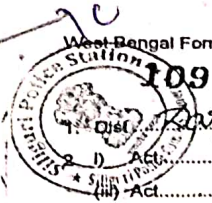

Respected Sir,

I the undersigned would like to draw your kind attention towards the fact that on 19.04.2023, my wife namely Ankita Bazari nee Kandoi, Daughter of Arun Kumar Kandoi having her father's residence, at C/O Sulabh Syntex, S.P. Mukherjee road, Near Gandhi Maidan, Post Office and Police Station: Siliguri, District: Darjeeling Pin: 734005, went missing from our residence. Following the incident on 20.04.2023 we lodged our missing complaint before your kind office which was diarized as G.D.E entry No. 537 dated 20.04.2023. After few days of the said incident we came to know that my wife eloped with one Subhajit Dutta, Son of Swapan Dutta, Resident of Zilla Parishad Road, Jyotinagar, Siliguri, Post Office and Police Station: Bhaktinagar, District: Darjeeling Pin: 734001, having Aadhar card No. 585642169893.

It is pertinent to mention here that while leaving our residence, my wife with in connivance with Subhajit Dutta stole jewelleryes worth 50 Lakhs and cash around 4 to 5 Lakhs which jointly belonged to my family members. That the description of the stolen jewelleryes what we could reminisce about are furnished herein below with separate column. From the wedlock with my wife, we are having two sons aged about 5 years and 14 years respectively. Initially, we believed that the offences were committed by my wife namely

Ankita Bazari nee Kandoi and at the request of her parents namely Shri Arun Kumar Kandoi and Smt. Asha Kandoi we kept mum about the aforesaid incident. The parents of my wife also promised to pay the requisite amount for the stolen jewellerys and cash but yesterday i.e. 10.08.2023 at around 11 PM when I was going through the Whatsapp chats of my elder son in his mobile phone I found out the conversation of my wife in between my son and her and from that chats it transparent that my wife and said Subhajit Dutta hedge up an obnoxious conspiracy to steal the said jewellerys and cash with an intention to cause pecuniary loss to our family. Unfortunately, this is not a first incident where she eloped. In the year 2015 she eloped with another man and stayed with him for one night and subsequently with the intervention of her parents and my family members she came back.

In these circumstances I would like to request you to start a specific case against these Accused Persons as per suitable provisions of law and further recover the stolen articles from their possession.
