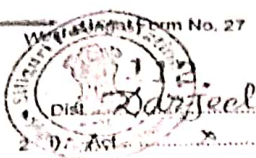

Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Flyover approach,

Sir,

I ASI Manotosh Barman of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 12.08.23 around 13.45 hrs, while on duty at Venus More found one (1) TOTO without any registration number stationed at Flyover approach, Venus More in such a way blocking free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Manish Saha (30yrs),(Contact No-7430003557) S/O- Shibnath Saha of Vill-Santipara,P.S-New Jalpaiguri, Dist-Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above named person (TOTO Driver) under proper section of law from your end.
