Sub-First Information Report.

Respected Sir,

With due respect and humble submission, I wish to inform you that a shortage of products, primarily edible oil, has been seen during the last one and a half years, particularly when internal counting is performed.

On 17 June 2023, one of our Loss Prevention Associate Mr Apurba Biswas noticed one bag Oil 1 Itr packet was kept hanging in a bicycle at parking area then he informed store Security authority, when the bicycle owner store's House Keeping Staff Mr Manmoy Bachhar was passing the premises with full bag of Oil then he had been asked the bill the House Keeping Staff Mr Manmoy Bachhar admitted that he had stolen the oil from the store and added that he had been stealing edible oil for the past year and a half. As a result, we reported the incident to the company's higher authorities in Kolkatta, West Bengal, and the undersigned is filling out this report based on instructions obtained from the higher authorities. Physical inventory count was done on 27 April 2023 and edible Oil negative shrinkage was posted Rs 521467.79 and previous Physical count (27 May 2022) Oil segment negative shrinkage was posted Rs 150763.00, a fresh inventory count of Oil segment was carried out on 24 June 2023 and a shrinkage reflected Rs 86517.20, resulting in total shrinkage of Rs 758747.99.

CCTV evidence against housekeeping staff Mr Monmay Bachhar's involvement was confirmed through CCTV footage validated on June 13, 14, 16, and 17, 2023 from the store.

Mr Monmay Bachhar, Housekeeping staff admitted in writing that he had been stealing edible oil for the past year and a half.

As a result, I humbly request that you look into the matter and take the appropriate legal actions to register the case against Housekeeping Staff Mr Monmay Bachhar under your kind consideration.

Note. The delay in filling FIR was due to when we first got to know the incident on dated 17 Jun 2023 and after that investigation was going on by Store's Security and Loss Prevention till dated 20. Jul 2023 and after that all the valid documentation sent to higher authorities Kolkatta and finally we received the instruction to lodge an FIR.
