Sub: Information regarding Theft of HDD from MSC room of Bharti Airtel Limited at Siliguri.

Dear Sir,

With due respect this is to Inform you that present complaint is being filed on behalf of Bharti Airtel Limited (referred to as "Airtel" or "Company" hereinafter) a company incorporated under the Companies Act 1956 having its registered office at Airtel Center, Plot No. 16, Udyog Vihar, Phase IV, Gurugram – 122015, Haryana and Circle office of Kolkata/WB Infinity Building, 5-7th Floor, Sector V, Salt lake Electronic Complex, Kolkata – 700091 represented by undersigned presently working for gain as Site Infra Manager at Siliguri MSC of Bharti Airtel Limited.

We would like to inform you that Airtel is engaged in providing mobile telephone service throughout the country including the telecom circles West Bengal and Kolkata.

We have our MSC cum office situated at Mouza: Dabgram, Plot No. 467/893, and 470/893, PS: Bhakti Nagar, Siliguri PIN:734004. Important and high valued telecom equipments are installed in the said MSC and the same is being maintained by the engineers as and when required. For the purpose of maintenance different planned and emergent activities are being carried out by the engineers from the support agencies of Bharti Airtel Limited. worthy to mention that the said MSC is having a critical role in transmission of signals to provide mobile and internet service to the customers. Considering the importance of the equipments, the MSC is covered by CCTV cameras to monitor the activities of the people working inside the same.

On 8<sup>th</sup> August 2023 one maintenance activity was planned and for the same our vendor company M/s. Identiqa deployed one engineer namely Mr. Abhishek Banerjee having mobile number-8906958114 from its partner company namely M/s. Techsys. Being duly permitted, the said engineer Mr. Abhishek Banerjee was allowed to enter into the MSC premises at about 11 P.M on 7<sup>th</sup> August 2023. Thereafter shown the mail approval to the Security Guard on duty and was allowed to enter into the MSC room at about 00:00 hours of 8<sup>th</sup> August 2023 and he remained inside the MSC room upto 02:45 hours of 8<sup>th</sup> August 2023.

On 9<sup>th</sup> August 2023 during alarm analysis our engineers of concerned department came to know that one hard disk drive (HDD) is missing from the MSC. Hence immediately we probed into the matter internally. On a thorough internal investigation we came to know that the HDD was removed from the concerned rack during the visiting hour of the aforesaid engineer. Thereafter we have verified our CCTV and found that the aforesaid Mr. Abhishek Banerjee was handling such

HDDs though it was not his part of purported activity. This apart he was also roaming inside the MSC room for which he was not authorized. Hence we have a suspicion on the aforesaid engineer for his involvement in such theft of HDD.

It is pertinent to mention here that the said HDD is containing highly sensitive information and data which may affect the security of the network and will cause damage to the telecom networking. Since the MSC room is covered by security whoever has got access to the above HDD and has stolen the same has committed offence.

Therefore, it is requested that your good self may be pleased to take up investigation to recover such HDD so also to apprehend the accused person(s) for theft of such HDD in order to punish them as per the provisions of law.
