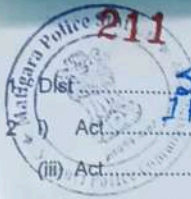

SUBJECT- Written Complaint against Khudiram Mandal S/o not known of
Patiramjote Under P.S- Matigara, Dist- Darjeeling.

Respected Sir,

With due respect I Saibalini Sarkar Mallick W/o Jatan Sarkar of
Patiramjote Under P.S- Matigara, Dist- Darjeeling would like to draw your kind
attention to the following effect that in the month of July, 2023, I along with Anita
Mandal purchased a Plot of land measuring about 5 katha bearing J.L No- 77, Plot
No- 417, Khatian No.1033 Mouza- Patiram Jote Under P.S- Matigara, Dist-
Darjeeling from Nimai Mandal S/o Lt. Mahendra mandol of Patiramjote Under P.S-
Matigara, Dist- Darjeeling and since purchase the aforesaid person threatening me
with dire consequences by saying that we have to pay at least Rs. 10 Lakh to him
as Gunda Tax very shortly, otherwise we will face severe problems, today at about
09:30 a.m. I along with my husband was going to Pradhannagar to bring my child
from school from our Residence but the aforesaid person restraint us at Achar
factory more, Patiramjote Under P.S- Matigara, Dist- Darjeeling, near in the house
of Ramjay sarkar and demanded money from us at that time my husband denied
to give him money for which aforesaid person became violent and hit on my
husband's belly with his hand (feast and blow) as a result my husband fell down, I
being a unfortunate wife tried to safe him then the aforesaid person snatched my
gold chain from my neck and also snatched Rs.3,000 from the shirt pocket of my
husband and torn my blouse and thereby committed the offence of outrage of
modesty of me by touching body, at that time some passersby in the locality
rescued us and my husband sustained stomach pain because previously he was
operated as hernia on his belly, thereafter I along with my husband and another
person namely Jayanand Sarkar went to Matigara Hospital for the treatment of my
husband but after preliminary treatment referred my husband to North Bengal
College & Hospital, Dist- Darjeeling.
Some unintentional delay is appeared to lodge this complain due to sudden illness
of my husband.

Therefore I request you to look into the matter seriously and take some
legal action as per law against the aforesaid person.
