In producing herewith following articles under proper seizure list -

1] 25 (Twenty-five) bottles of Himalayan Gold 60 UP Country spirit (each bottle containing 600 ml)

I, PSI Koushik Raha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1. Rabi Chowdhury, S/O-Late Raghu Chowdhury of Khudirampally, near Kali Mandir, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 13/08/2023 while performing evening patrolling duty, received a source information that one person is selling liquor in his house situated at Khudirampally, near Kali Mandir under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/374 Debraj Biswas, C/ 1426 Prashanta Kumar Dutta had been to Khudirampally, near Kali Mandir under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source I along with my force cordoned the house of the above noted person. But seeing us the above noted accused person could manage to flee away from the spot. I held a raid in his house in which I recovered the above noted bottles of liquors inside of his house. I searched for its claimant but nobody came forward and produced any valid document in support of those bottles of liquors. I also examined several local people from whom identity of the owner of the said shop ascertained as mentioned above and also learnt that the above noted bottles of liquors were procured and stored by the above noted accused person illegally. During local enquiry it is also came to learn that Rabi Chowdhury, S/O-Late Raghu Chowdhury of Khudirampally, near Kali Mandir, P.S- Bhaktinagar, Dist- Jalpaiguri was running this business in his house who used to sell it to the local youths since last 04 (Four) months for his illegal gain. Accordingly, I seized the above noted bottles of liquors as alamats under proper seizure list. The search and seizure was made in between 21.05 hrs to 21.35 hrs. The alleged person fled away during the raid after taking advantage of darkness to evade Police arrest

I, therefore pray before your good self that a specific case may kindly be initiated against Rabi Chowdhury, S/O-Late Raghu Chowdhury of Khudirampally, near Kali Mandir, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
