Sir,

In producing herewith one accused person namely Sunil Sahani-31yrs s/o Bindeswar Sahani of Sahani busty, Prakashnagar ward no-42, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10 (Ten) no's of pet bottles Himalayan FATAFATI country spirit each bottle containing 300 ML
2. 10 (Ten) no's of pet bottles Himalayan gold country spirit each bottle containing 600 ML
3. Two bottles of Imperial Blue each bottle containing 750 ML which was packed in one big nylon hand bag.

With due respect and humble submission, I PSI Koushik Raha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the above noted seized articles to the effect that on 14.08.23 at 16.05hrs while performing PS mobile van duty received a source information from Sahani busty, Prakashnagar under Bhaktinagar PS that one person namely Sunil Sahani was selling wine in the open market for his wrongful gain without any documents/license in his house. Diarized the fact in GD vide Bhaktinagar PS GDE No-708 dated 14.08.23. As per your kind instruction myself along with SI Mrinal Basunia, PSI Chiranjit Saha, CV/619 Dharmendra Roy and C/1426 Prasanta Kumar Dutta proceeded to the PO to work out the information. At 17.20 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his house. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO after prepared proper seizure list. (The seizure was made in between 17.35 hrs to 18.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Sunil Sahani-31yrs s/o Bindeswar Sahani of Sahani busty, Prakashnagar ward no-42, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
