Diarized the fact in GD vide Bhaktinagar PS GDE No-708 dated 14.08.23. As per your kind instruction myself along with SI Mrinal Basunia, PSI Chiranjit Saha, CV/619 Dharmendra Roy and C/1426 Prasanta Kumar Dutta proceeded to the PO to work out the information.
