Respected Sir,

With due respect and humble submission I Subrata Pradhan wife of Sri Prasanta Pradhan and Daughter of Late Ganesh Pradhan of Sherpa Busty Post Office and Police Station Kurseong District Darjeeling presently staying in Flat No. B/12, Arjun Grace Homes Salbari Post Office Salbari , Police Station Pradhan Nagar Siliguri District Darjeeling would like to inform you that I am married to one Prasanta Subba on 24.11.2022 in my Kurseong home and after the marriage we started living in my husband's home in Gandhi Gram. After few days in the month of March I got a job in Health Department and posted in Gorubathan and with the mutual consent of both myself and my husband we started living in Salbari in Parijat Road and I also booked one 2bhk Flat in salbari as it was convenient to both of us to go our respective offices as my husband is also a Government servant and employed in Fire Brigade in Kurseong.

Everything was alright from the month of May he tried to interfere with that finances of my family members but when I refused and also requested him not to do so he used to physically assault me and I used to suffer from bruise and cuts but thinking to keep safe my marriage I dint said anything to anyone and after such day his total behavior against me has changed. Then gradually he stopped talking to me and when he used to leave me and returned to salbari home after 4-5 days without any news where he is going and used to block my number. This was his routine behavior and when I used to ask him he used to fight and quarrel with me and tried to hit the house articles forcefully with the intention of scaring me. I tried to convince him in many ways I even tried to speak with my mother-in-law but she also paid no heed. I tried to talk to his brother who is also Sub-Inspector and currently posted in Kalimpong Police Station he also never helped me and said that it is my family matter and i should deal with this. Due to his frequent quarrel he felt ashamed and forced me to shift the house as the neighbours started complaining about his fighting mentality.

That after such still as my marriage was new I wanted to give him a chance and I shifted the house to Arjun Grace Homes in salbari. His younger brother who is in kalimpong never treated me good neither my mother-in-law. At the time when my sister in law conceived the baby they even not informed anyone from us but I took my mother in law to see the baby in Nayaks Nursing Home Siliguri.

That on 12.08.2023 he forced me to go to Kalimpong and I refused as I was not feeling well as he was also just came from Kolkata and I was also not feeling well in just my such request he started quarreling me and abusing me, he in turn started hitting the house materials with kicks and blows and when I started to stop him he started hitting me tried to strangulate me with his bare hands with the intention to kill me and when I tried to scream he left me and kicked the sofa and left the house and from that date his phone is blocked. He never tried to contact me neither I can try to contact him. When my family members tried to contact him or his family members they have blocked the all the numbers like they have deserted me and my family. Everytime he used to feel furious when I used to spend my money in my house. He started threatening me not to meet my mother, sister and my family members. In every manner he tortured me physically and mentally and now it is very much impossible for me to live with him as I am very scared as I have to stay only with him and anytime he might kill me and disappear and neither his family members have any concern about me. Therefore sir, kindly take strict action against this person Prasanta Subba who thinks that marriage is just a game and he can willfully torture his wife by any means as the crime is not serious nowadays. Further kindly teach him a good lesson that at this time it is very illegal to demand any money from the wife after the marriage and any money of mine is my share and it's my lookout where I spend and my husband have no right to interfere and physically assault me to forcefully handover my money to my husband.
