I, Subham Nath, son of Dilip Kumar Nath, des'dent of 20, J.B. Sarani, Haldi Para Siliguri, ward NO XV SMC, P.O & P.S. Siliguri, would to inform you that it

- 1) That I have business named - NEW D.K. Nath & Sons, Supplier of Bakery raw materials & ingredients.
- 2) That, Kaotik Goel, son of Ramesh Goel, des'dent of Panchali Sonder Apartment, 2nd building, Changuhati Kali mandir Road. He has been our customer since 2019, we have pending amount of Rs 2,12,900/- since 30<sup>th</sup> August 2022 which he promised to pay within Oct' 2022.
- 3) After the given time and extra time we tried to contact him several times, but he did not respond. We went several times to his factory and home also. But he was not cooperative with us.
- 4) He makes false promises of giving payment after 15 days or months but he never did the payment. We still have pending 2,12,900/-
- 5) That on 30, 07, 2023 at about 9.30 am. I along with my business colleagues, those who also checked by him went his factory first, but

he was not there, Then we went to his des'i dental place to visit him, when we met I asked him to kindly pay our outstanding dues, Then he suddenly became furious and called his wife, both of them started hurling abuses at us, and said that he will not clear the outstanding dues. His wife also threatened us saying " Do whatever you want to do, I do not fear any police, I am an advocate and I will lodge a false F.I.R against you all."

I therefore request you to kindly take necessary legal steps against Kastik Gopal and helps us recover our pending dues from him.
