This is to inform you that I, Smt. Sangita Das, wife of Sri Anupam Ghosh, daughter of Sri Swapan Das, resident of Ward No. 11, Ashok Nagar, P.O. Jalpaiguri, P.S. Jalpaiguri (Kotwali), Dist. Jalpaiguri, Pin no. 735101, presently residing at my parental house at Thiknikata, near NBMC, P.O. Sushruta Nagar, P.S. Matigara, Dist. Darjeeling, Pin no. 734012, beg to inform you that my marriage was registered on 09/10/2020 with Sri Anupam Ghosh, son of Sri Gouranga Ghosh, resident of Ward No. 11, Ashok Nagar, P.O. Jalpaiguri, P.S. Jalpaiguri (Kotwali), Dist. Jalpaiguri, Pin no. 735101, as per Under Section 13 of ACTXLIII of 1954 and thereafter our marriage had been solemnized on 24/11/2020 as per Hindu Rights and Customs at presence of the relatives and well wishers of both the family members.

That at the time of the our marriage my father had given (i) One Box Khat, (ii) One Almirah, (iii) One Dressing Table, (iv) One Refrigerator, (v) one Washing Machine, (vi) 40 inch LED TV, (vii) Gold Ornaments like (a) Golden Chain for my husband, (b) Gold Ginger Ring, (c) Gold Chain for Me, (d) 1 set of Ear Ring, (e) 1 Pair of Gold Bala, (f) 1 Sofa Set, (g) 1 Gold Neckless, (h) 2 Gold Sakha Pola, (i) 2 Ps Mangal Sutra (j) 2 Ps. Gold Ring and (viii) Rs. 5,00,000/- (Rupees Five Lakhs) cash as per the sole demand of my husband and his family members.

That since after 7 (seven) days of my marriage (i) my husband namely Sri Anupam Ghosh, son of Sri Gouranga Ghosh, (ii) my mother-in-law namely Smt. Mumu Ghosh, wife of Sri Gouranga Ghosh, (iii) my father-in-law namely Sri Gouranga Ghosh, son of Late Manindra Chandra Ghosh and (iv) my brother-in-law namely Sri Shoumik Ghosh, son of Sri Gouranga Ghosh started misbehave with me and they always told me that I belongs to poor family as such I had not any right to be daughter-in-law of their family. They always told me to bring money from my parents and I always told them that at the time of marriage my father had already given all the aforesaid articles along with Rs. 5,00,000/- (Rupees Five Lakhs) only cash

as per their demand and at present my father is not in the position to give anything more to them.

That thereafter on 21/02/2022 I gave birth of one girl child namely Miss Anushka Ghosh and thereafter the level of torture both mentally and physically had been increased as I gave birth of a Girl Child as they wanted to be a Male Child and my husband and in-laws started to torture upon me demanding money from my parental house.

That it is also pertinent to mention-here-in that my brother-in-law namely Shoumik Ghosh, son of - Sri Gouranga Ghosh, has a bad character in person, sometimes he entered my bed room without knocking the door and he always look at me with bad intention and lastly in the month of May, 2023 my said brother in-in-law forcefully tried hug me in absence my husband with bad intention and when I disclosed the said matter before my in-laws family members then they never asked to my brother-in-law that why he did it rather they all became furious and started beating me mercilessly and my father-in-law assaulted me and my brother-in-law pushed me on the ground and torn my dresses and touched my chest and back and my mother-in-law used slang language to me and driven me out from my bed room and kicked my back. Thereafter somehow I managed the situation with the initiative of my family members and on request on the part of my husband, I stayed with them with a hope that one day the situation should be normal.

It is also pertinent to mention here-in-that I am a student of St. Fernando College of Nursing, as such I went to give examination in Bangalore in the month of June, 2023 and at that time my baby girl was kept in my matrimonial house and when I came from there on 19/07/2023, I went to my matrimonial house then my husband and my in-laws closed the main door of their house and they did not want to enter me in their house but somehow I entered in the said house as my baby girl was there and they used to keep me under lock and key and they did not provide any foods to me. Thereafter on 26/07/2023 my husband and all my aforesaid in-laws started beaten me heavily in my head, chest with a motive to kill me with a planned manner and I became senseless there without any reason and they also torn my cloths and when I regain my sense then they forcefully driven me out along with my baby girl from my matrimonial house. Thereafter, I called my mother and then my mother and my minor little

brother came there and rescued me there from and since the date of driven out I am residing with my parental house at NBMCH, Thiknikata, P.O. Sushruta Nagar, P.S. Matigara, Dist. Darjeeling, Pin no. 734012 and I sustained injury and got heavy internal pain in my head and due to unable to tolerate the said pain I was admitted in NBMC & H on 09/08/2023 and till date I am treating there.

It is also pertinent to mention here-in-that yesterdayon 15/08/2023 at about 10.00 pm my husband along withof his some relatives came to my parental house at Thiknikata and they forcefully demanded Mutual Divorce from me and forced me to put signature on a Mutual Divorce paper, as my husband can remarry and they also forcefully tried to take the custody of my minor girl child and when I have resist for their illegal acts then they started use filthy languages towards me and threatened me with dire consequences and on hot altercations they all forcefully pushed me on the ground and when I started to shout then they all flew away from my parental house and after this incident I am passing my every moment with great fear and anxiety and there is a chance that they can kidnap my minor child at any point of time..

Therefore, you are requested to take appropriate legal action against (i) my husband namely **Anupam Ghosh**, (ii) my mother-in-law namely **Mumu Ghosh**, (iii) my father-in-law namely **Gouranga Ghosh**, and (iv) my brother-in-law namely **Shoumik Ghosh** for the illegal acts which have been done with me by them and obliged.
