Sir,

In producing herewith 04 (four) arrested accused persons namely (i) Md. Afzal (20) S/O Md. Alam of Railgate, Biswas Colony, PO+PS-Matigara, Dist-Darjeeling (ii) Md. Gulmohammad (22) S/O Lt. Md. Anwar of Hospital More Alam Busty PO+PS-Matigara, Dist-Darjeeling (iii) Sudhan Kumal (23) S/O Birbal Kumal of Deunia More near Nightingale Hospital, Tarijote, PS-Matigara, Dist-Darjeeling (Not verified) and (iv) Krishna Dev Choudhury (21) S/O Suresh Prasad Choudhury of Deunia More near Nightingale Hospital, Tarijote, PS-Matigara, Dist-Darjeeling (Not verified) (arrested u/s- 41 Cr.P.C) along with following seized articles viz:

- (1) One iron made 'Knife' found from the possession of Md. Afzal which was kept in his right hand.
- (2) One iron made 'Crowbar' found from the possession of Md. Gulmohammad which was kept in his right hand.
- (3) One iron made 'Bhojali' found from the possession of Krishna Dev Choudhury which was kept on his left hand.
- (4) One iron rod measuring approximately 3" found from the exclusive possession of Sudhan Kumal which was kept in his right hand.

I, SI Ager Lepcha of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Md. Afzal (ii) Md. Gulmohammad (iii) Sudhan Kumal (iv) Krishna Dev Choudhury and others to the effect that today on 19/08/2023 at 00:35 hrs received a source information that 8/10 youths have assembled at Tiranga More, Tumbajote under Matigara PS with a view to commit dacoity in a house near Tiranga More Tumbajote. Subsequently, after sharing the information with my superiors and as per their direction, I along with SI Sailesh Subba, ASI Pema Dorjee Sherpa C/523 Sanjit Kundu and C/219 Sanatan Chitrakar, all of Matigara PS, SPC, left for the place to work out the information. At about 01:45 hrs after reaching near Tiranga More, Tumbajote under Matigara PS, I met my source and being pointed by the source we started walking towards Tiranga More. At 02:25 hrs we reached at Tiranga More and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot. Seeing police personnel approaching towards them they tried to flee away, but on hot chase we managed to apprehend above noted 04(four) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a house at Tiranga More Tumbajote.

I thereafter, seized the above noted deadly weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 03:05 hrs to 03:20 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Tiranga More Tumbajote. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons namely (i) Md. Afzal (20) S/O Md. Alam of Railgate, Biswas Colony, PO+PS-Matigara, Dist-Darjeeling (ii) Md. Gulmohammad (22) S/O Lt. Md. Anwar of Hospital More Alam Busty PO+PS-Matigara, Dist-Darjeeling (iii) Sudhan Kumal (23) S/O Birbal Kumal of Deunia More near Nightingale Hospital, Tarijote, PS-Matigara, Dist-Darjeeling (Not verified) and (iv) Krishna Dev Choudhury (21) S/O Suresh Prasad Choudhury of Deunia More near Nightingale Hospital, Tarijote, PS-Matigara, Dist-Darjeeling (Not verified) and others and arrange for its investigation.
