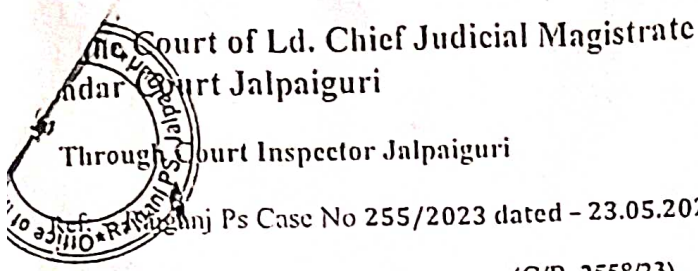

Sub :- Prayer for pass an order to transfer the above reference case and also to hand over the original case diary to O/C NJP PS. Jalpaiguri.

Sir,

With due respect and humble submission I beg to report that, on 23.05.2023 at 10.05 hrs received a written complaint from SI Shiva Dural of Rajganj PS, Dist- Jalpaiguri against the driver of one unknown vehicle to the effect that today on 23.05.2023 at about 04.30 hrs in course of his highway mobile van duty, received a telephonic information that an accident occurred at Diversion near Siliguri Greater Lions Eye Hospital, Majhiali GP on NH 31D. After receiving this information, he along with force hastened to the spot and found one vagabond type male person aged around 45 years was lying on the road with bleeding injuries. He tried to ascertain his identity but he was not in a position to disclose anything. Accordingly, he contacted with NH authority and shifted the injured person by ambulance of NH authority to NBMC & Hospital Siliguri for his treatment. It is appeared that the above noted person might have dashed by any vehicle as a result of which he sustained injuries. Over this written complaint started the above noted case and as per endorsement of I/C Rajganj PS, I PSI Nima Sherpa took up its investigation.

During investigation, I examined the complainant thoroughly and his statement was fully corroborated with the FIR. Hence, I did not record his statement further. I also visited the PO and drew up its rough sketch map with its index and examined available witnesses and recorded their statement u/s 161 Cr.PC. It is revealed in course of investigation that the PO is situated at Diversion near Siliguri Greater Lions Eye Hospital which falls under the jurisdiction of NJP PS area. I also collected the Pradhan certificate from Pradhan of Majhiali G.P. who also stated that, the P.O. is falls under the jurisdiction of Ambari Out Post under NJP PS, SPC.

Hence, I pray before your honours Court that, an order may kindly be passed an order to transfer the above reference case and also to hand over the original case diary to O/C NJP PS, Jalpaiguri for its investigation in question of jurisdiction.
