CHANARDIP ROY, SOUTH AMBEDKAR COLONY, PRADHANNAGAR with Con Id- **412241469**, Installation No- **608979**, Meter No. **L321303** having Osd-Rs. 44990.00/- as on date 18.08.2023, two women from his house created ruckus, verbally abused our staffs and pelted stones at our disconnection team.
