Sir,

This is to bring to your notice that I Arijit Guha Roy S/o Swapan Guha Roy, a resident of Ajit mansion, Ramkrishna Road 4th Bylane, Opp Angela High School, Ashrampara, Siliguri have faced violence on a public street in my own locality (Amtala Road/Nazrul sarani crossing) on 16th of August 2023, at about 09.00 PM.

The incident occurred when I left from my home along with friends to a salon. Few boys were standing on the side of the road with their bikes seeing them the bike in front of me abruptly braked in the middle of the road. I said to him that he could have stopped at the side and not obstruct traffic. As soon as I got a little space on the side, I pushed forward avoiding collision and confrontation. Then he still followed my vehicle and kept passing unparliamentary comments. I avoided any interaction as I was accompanied by a lady and did not want any extraordinary situation. To my surprise the group overtook my vehicle and blocked my way to forcefully stop me and the lady. They burst into a complete rant of slangs and slurs despite several provocation when I didn't reciprocate their negative excitement three of the boys physically assaulted me in the middle of the road and slowly moved aside when a crowd assimilated. One bystander who was standing there pretended to settle things but also made sure the culprits ran away under the cover of the crowd before the PCR van arrived on the spot. On further questioning from the officer in the PCR he admitted to knowing them personally and that they belong to the same locality. The culprits have also clicked the picture and taken videos of the lady and her scooter with the license plate. Along with the assault on me this incident has also shocked her and she is unable to continue with her normal daily life due to fear of her safety within the city.

I have hereby attached 6 photos of the spot in the annexure below. Which includes the license plate of one bike (WB 74 AH 9679) and face of all three culprits (We have also forwarded these pictures to the officer from PCR van on his WhatsApp on the same day). I have also attached a picture of the medical checkup prescription from the Siliguri Municipal hospital where I reached due to terrible discomfort in the injured area (eye).

As a resident of this city I am absolutely surprised at this and am unable to go out normally and continue my normal routine. Such unwarranted and rash behaviour is not expected from anybody at such a reputed locality. Such behaviour can cause unwanted injuries and fear within the residents. I am deeply affected by this incident. The location of my injury is just above my right eye which could have been a fatal injury otherwise.
